MEASURE K: RESOLUTION AUTHORIZING FIVE (5) AGREEMENTS FOR THE PURPOSE OF OPERATING THE BIG LIFT EARLY LEARNING INITIATIVE TO INCREASE KINDERGARTEN READINESS, AND GROW THIRD-GRADE READING PROFICIENCY IN SAN MATEO COUNTY WITH THE FOLLOWING SCHOOL DISTRICTS, EACH FOR THE TERM OF JULY 1, 2026 THROUGH JUNE 30, 2027, FOR A COMBINED AGGREGATE AMOUNT NOT TO EXCEED \$1,748,808:

- A) BAYSHORE SCHOOL DISTRICT IN AN AMOUNT NOT TO EXCEED \$266,720; AND**
- B) CABRILLO UNIFIED SCHOOL DISTRICT IN AN AMOUNT NOT TO EXCEED \$316,880; AND**
- C) LA HONDA-PESCADERO UNIFIED SCHOOL DISTRICT IN AN AMOUNT NOT TO EXCEED \$331,730; AND**
- D) SAN BRUNO PARK SCHOOL DISTRICT IN AN AMOUNT NOT TO EXCEED \$347,650; AND**
- E) SOUTH SAN FRANCISCO UNIFIED SCHOOL DISTRICT IN AN AMOUNT NOT TO EXCEED \$485,828**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, The Big Lift is a collective impact initiative led by the County of San Mateo Human Services Agency (HSA), the San Mateo County Office of Education (COE), and the San Mateo County Libraries (SMCL); and

WHEREAS, On March 17, 2025, the Board approved recommended **Measure K** budget allocations for The Big Lift Program in preparation for the Fiscal Year 2026 - 2027 Recommended Budget; and

WHEREAS, the Human Services Agency seeks authorization from the Board of Supervisors to enter into the following agreements each for a term of July 1, 2026 through June 30, 2027, in an aggregate amount not to exceed \$1,748,808:

- A) Bayshore School District: \$266,720; and
- B) Cabrillo Unified School District: \$316,880; and
- C) La Honda-Pescadero Unified School District: \$331,730; and
- D) San Bruno Park School District: \$347,650; and
- E) South San Francisco Unified School District: \$485,828.

WHEREAS, this Board has been presented with forms of said agreements and has examined them and approved them as to both form and content and desires to enter into the agreements.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Director of the Human Services Agency or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
