RESOLUTION AUTHORIZING AN AGREEMENT WITH JESSICA MARONE, MD TO PROVIDE PAIN MANAGEMENT AND MUSCULOSKELETAL MEDICINE SERVICES, FOR THE TERM OF OCTOBER 1, 2025 THROUGH SEPTEMBER 30, 2026, IN AN AMOUNT NOT TO EXCEED \$468,008, AND AUTHORIZING AND DIRECTING THE PRESIDENT OF THE BOARD OF SUPERVISORS TO EXECUTE THE AGREEMENT ON BEHALF OF THE COUNTY

**RESOLVED,** by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County of San Mateo has a need to replace a previously departed physician's coverage with a specialist who can provide non-anesthesia pain management and musculoskeletal administrative leadership at San Mateo Medical Center by serving as its Medical Director of Physiatry; and

WHEREAS, Jessica Marone, M.D. ("Dr. Marone") is a qualified painmanagement specialist who is willing and able to provide those services at San Mateo Medical Center; and

WHEREAS, this Board has been presented with an agreement, under which Dr. Marone will provide pain management and musculoskeletal medicine services for the term of October 1, 2025 through September 30, 2026, in an amount not to exceed \$468,008 ("Agreement"), has examined and approved the Agreement as both form and content, and desires to enter into it.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Agreement is approved and the President of the Board of Supervisors be and is authorized and directed to execute the Agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Chief of San Mateo County Health, or designee, is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate) and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
