RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH AECOM TECHNICAL SERVICES, INC. TO PROVIDE ENGINEERING AND OTHER RELATED PROFESSIONAL AND TECHNICAL SERVICES FOR THE MIDDLEFIELD ROAD IMPROVEMENT PROJECT, EXTENDING THE TERM THROUGH MARCH 31, 2024, AND INCREASING THE AMOUNT BY \$228,000 TO AN AMOUNT NOT TO EXCEED \$2,536,184

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on November of 2011, this Board adopted the North Fair

Oaks Community Plan, which included the improvement of Middlefield Road

between Fifth Avenue and Pacific Avenue to create a more attractive street that is

more pedestrian and bike friendly; and

WHEREAS, on July 9, 2013, this Board approved funding for Measure A (now Measure K) funding to redesign and make improvements to Middlefield Road including improvements to the South County Health Clinic (and Redwood Junction) Entrance and Intersection Improvements; and

WHEREAS, on October 21, 2014, this Board approved the recommendations from the North Fair Oaks Community Council (Council) regarding improvements to Middlefield Road between Pacific Avenue and Fifth Avenue to include three traffic lanes (one travel lane in each direction with a center left turn lane), parallel parking, bike lanes, and wider sidewalks; and

WHEREAS, this Board of Supervisors did, on May 19, 2015, adopt Resolution

No. 073802, which authorized the execution of an agreement with AECOM Technical

Services, Inc. (AECOM) for the Middlefield Road Improvement Project (Project), in an amount not to exceed \$1,729,061; and

WHEREAS, the Director of Public Works authorized Amendment No. 1 extending the term of the agreement with AECOM from May 19, 2018 to June 30, 2019; and

WHEREAS, the Director of Public Works authorized Amendment No. 2 extending the term of the agreement with AECOM from July 1, 2019 to December 31, 2022; and

WHEREAS, this Board of Supervisors did, on October 22, 2019 adopt Resolution No. 077010, which authorized Amendment No. 3 and increased the not to exceed amount of the agreement with AECOM by \$342,498 to \$2,071,559; and

WHEREAS, this Board of Supervisors did, on October 19, 2021 adopt Resolution No. 078498, which authorized Amendment No. 4 and increased the not to exceed amount of the agreement with AECOM by \$236,625 to \$2,308,184; and

WHEREAS, AECOM's effort relative to providing ongoing design support during Project construction is greater than anticipated due to several unanticipated underground conflicts encountered during construction; and

WHEREAS, the engineering services for ongoing construction support through completion of the Project is estimated to be approximately \$228,000; and

WHEREAS, AECOM continues to be a competent civil engineering firm with employees duly licensed to perform such engineering services in connection with said Project, their work performed to date in connection with this Project has been

responsive and acceptable, and the parties hereto desire to increase the not to exceed amount by \$228,000 to \$2,536,184; and

WHEREAS, the Director of Public Works recommends execution of Amendment No. 5 to the agreement with AECOM to extend the term through March 31, 2024 and increase the amount by \$228,000 to a new not to exceed amount of \$2,536,184; and

WHEREAS, the Board has considered and concurs with the recommendation of the Director of Public Works.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors be and is hereby authorized and directed to execute said Amendment No. 5 with AECOM, for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.
