RESOLUTION ESTABLISHING A "NO PARKING" ZONE ON THE SOUTHERLY SIDE OF BAY ROAD COMMENCING AT A POINT 59 FEET EASTERLY OF THE INTERSECTION OF WARRINGTON AVENUE AND EXTENDING A DISTANCE OF 89 FEET, MORE OR LESS IN THE UNINCORPORATED NORTH FAIR OAKS AREA

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507, et seq., and Section 7.30.010 of the San Mateo County Ordinance Code allow this Board of Supervisors to prohibit or restrict the stopping, parking or standing of vehicles by resolution or ordinance with associated signs and markings; and

WHEREAS, SamTrans seeks to improve operations, visibility and access for passengers at the bus stop on Bay Road near Warrington Avenue in the unincorporated North Fair Oaks area; and

WHEREAS, the Department of Public Works has evaluated the area and determined that restricting parking at the bus stop on the southerly side of Bay Road near Warrington Avenue will improve passenger visibility and enhance access; and

WHEREAS, the Director of Public Works has recommended that a "No Parking" zone be established as noted herein and on Exhibit A attached hereto; and

WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

- A "No Parking" zone is declared to exist on the southerly side of Bay Road
 (County Road R-32E) commencing at a point 59 feet easterly of the center line of
 Warrington Avenue and extending easterly on Bay Road a distance of 89 feet,
 more or less.
- The Department of Public Works is authorized and directed to post any necessary signs and pavement markings.
