RESOLUTION 075338 TO DELETE TWO POSITIONS, ADD TWO POSITIONS,  
RECLASSIFY ONE POSITION, SPLIT ONE POSITION TO TWO HALF TIME  
POSITIONS, AND ADJUST THE SALARY OF EIGHT CLASSIFICATIONS.**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

**WHEREAS**, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

**WHEREAS**, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

**NOW THEREFORE, IT IS HEREBY ORDERED** that the Board of Supervisors authorizes an amendment to Master Salary Resolution 075338 as follows:

**ORGANIZATION 18000 INFORMATION SERVICES DEPARTMENT**

1. Item E029, Administrative Assistant I is decreased by 1 position for a new total of 1 position.

2. Item G247S, Contract Administrator Series is increased by 1 position for a new total of 1 position.

#### ORGANIZATION 55100 HEALTH COVERAGE UNIT

1. Item E483S, Health Benefits Analyst Series is decreased by 1 position for a new total of 20 positions.

#### ORGANIZATION 66000 SAN MATEO MEDICAL CENTER

1. Item F009S, Patient Care Series is increased by 1 position for a new total of 422 positions.
2. Item E483S, Health Benefits Analyst Series is increased by 1 position for a new total of 1 position.
3. Item E415, Patient Services Supervisor – E is decreased by 1 position for a new total of 17 positions.
4. Item D182S, Management Analyst Series is increased by 1 position for a new total of 12 positions.
5. Salary Range for Item D034, Clinical Services Manager – Respiratory Therapy is set at \$49.82 - \$62.27 per hour.
