

**Third Amendment to Agreement**  
**Between the County of San Mateo and Sutter Bay Medical Foundation, a California nonprofit public benefit corporation dba Palo Alto Medical Foundation for Health Care, Research, and Education for General Surgery Services**

THIS AMENDMENT TO THE AGREEMENT, entered into **this\_\_\_\_\_ day of \_\_\_\_\_2025**, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Sutter Bay Medical Foundation, a California nonprofit public benefit corporation dba Palo Alto Medical Foundation for Health Care, Research, and Education, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for **General Surgery** services for the term of July 1, 2021 through June 30, 2024, in an amount not to exceed \$ 2,843,595.00 (the "Agreement"); and

WHEREAS, on June 25, 2024 the parties agreed to extend the term of the Agreement by six months through December 31, 2024 by amendment and increased the "not to exceed" amount of the Agreement by \$473,934.00 to an amount not to exceed \$3,317,529.00; and

WHEREAS, on December 20, 2024 the parties further agreed to extend the term of the agreement by an additional three months through March 31, 2025, increase the amount payable under the Agreement by \$236,967.00 to an amount not to exceed \$3,554,496.00 to accommodate the services provided under the extended term, and update the approved list of Contractor Providers; and

WHEREAS, the parties desire to extend the term of the agreement by an additional nine months through December 31, 2025, increase the amount payable under the Agreement by \$ 710,896.50 to accommodate the services provided under the extended term;

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

1. Section 3.1 of the Agreement (entitled **Term**) is amended to read as follows:

The term of this Agreement is July 1, 2021 through December 31, 2025.

2. **EXHIBIT B** (entitled **PAYMENTS**) Section VIII. Is amended to read as follows:

Unless increased pursuant to Paragraph g. of Section VII. of Exhibit A, total payment for services under this agreement will not exceed NINE HUNDRED FORTY-SEVEN THOUSAND EIGHT HUNDRED SIXTY-FIVE DOLLARS (\$947,865.00) per year. Over the four year and six-month term of this Agreement the maximum amount payable will not exceed FOUR MILLION TWO HUNDRED SIXTY FIVE THOUSAND THREE HUNDRED NINETY TWO DOLLARS AND FIFTY CENTS (\$4,265,392.50).

3. **All other terms and conditions of the Agreement shall remain in full force and effect.**
