**RESOLUTION CERTIFYING THE MILEAGE IN THE COUNTY OF SAN MATEO'S
MAINTAINED ROAD SYSTEM TO BE 315.934 MILES AS OF DECEMBER 31, 2025**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Section 2121 of the California Streets and Highway Code provides that each year counties shall submit to the California Department of Transportation the additions to and deletions from their total mileage of maintained county roads; and

WHEREAS, the California Department of Transportation certified to the State Controller that the total mileage of County-maintained roads in the County of San Mateo, as of December 31, 2024 was 316.212 miles; and

WHEREAS, the Director of Public Works has reported that as of December 31, 2025, there was a 0.278-mile decrease to the total mileage of maintained County roads; and

WHEREAS, the Director of Public Works has also reported that as of December 31, 2025, the total mileage of maintained County roads is 315.934 miles.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED based on the information provided by the Director of Public Works, that this Board certifies the County maintained mileage as described in Exhibit "A", "Summary of County of San Mateo Maintained Road Mileage as of December 31, 2025" attached hereto and made

a part hereof, which indicates that the mileage of County of San Mateo-maintained roads as of December 31, 2025 is 315.934 miles.

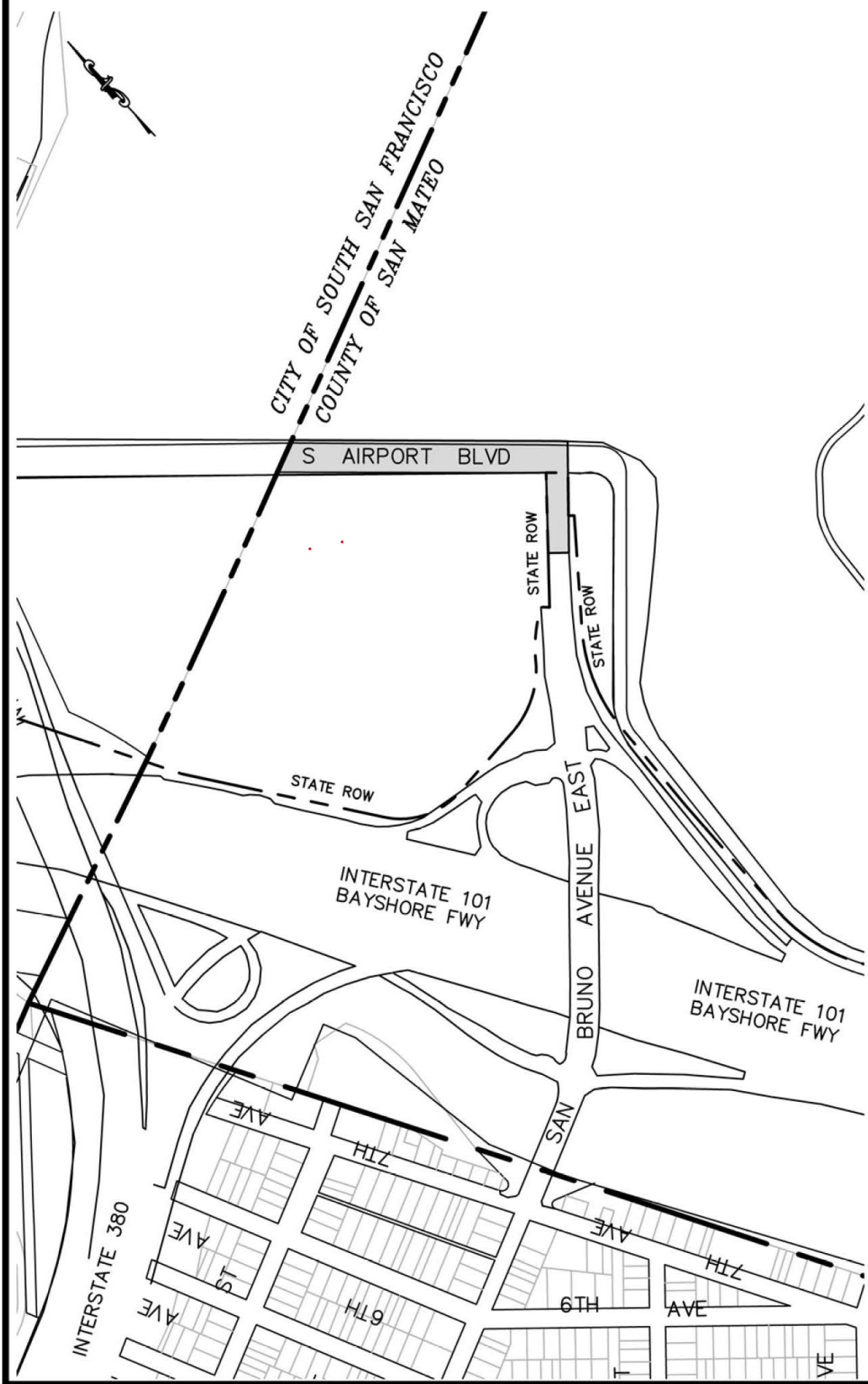

0.000 Additions and 0.278 Deletions to Maintained Road Mileage in 2025

1. **SOUTH AIRPORT BOULEVARD, (County Road No. 189)**, San Francisco International Airport Area of San Bruno:
 - **Existing:** Segment from County/City of South San Francisco Boundary to San Bruno Avenue East (County Road Number 9) was re-logged and decreased 0.065 centerline miles with the new length of 0.165 centerline miles.
 - **Quitclaim:** Segment from County/City of South San Francisco Boundary to San Bruno Avenue East (County Road Number 9) was quitclaimed to the City and County of San Francisco, per Resolution No. 081115 adopted by this Board of Supervisors on May 6, 2025 (Quitclaim Deed 2025-040472) and decreased 0.165 centerline miles with the new length of 0.000 centerline miles.

2. **SAN BRUNO AVENUE EAST, (County Road No. 9)**, San Francisco International Airport Area of San Bruno:
 - **Quitclaim:** Segment from 0.048 miles west of South Airport Boulevard to South Airport Boulevard (County Road Number 189) was quitclaimed to the City and County of San Francisco, per Resolution No. 081115 adopted by this Board of Supervisors on May 6, 2025 (Quitclaim Deed 2025-040472) and decreased 0.048 centerline miles with the new length of 0.372 centerline miles.
