

**FIRST AMENDMENT TO AGREEMENT  
BETWEEN THE COUNTY OF SAN MATEO AND  
HUBERT B. SHIH, MD**

THIS AMENDMENT TO THE AGREEMENT, entered into the later of this \_\_\_\_ day of \_\_\_\_\_, 2022, or the date last signed below by and between the COUNTY OF SAN MATEO, hereinafter called "County," and **Hubert B. Shih, MD**, hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for plastic specialty services effective October 1, 2020 in an amount not to exceed \$ 600,000.00; and

WHEREAS, on July 26, 2022 the parties further amended the Agreement to add \$ 25,000.00 to the amount payable under the agreement for a new "Not to Exceed Amount" of \$ 625,000.00; and

WHEREAS, on August 23, 2022 the parties further amended the Agreement to extend the term of the Agreement from October 1, 2020 through September 30, 2022 to October 1, 2020 through October 31, 2022 and add \$ 25,000.00 to the amount payable under the agreement for a new "Not To Exceed Amount" of \$ 650,000.00; and

WHEREAS, the parties wish to further amend the Agreement to extend the term of the Agreement from October 1, 2020 through October 31, 2022 to October 1, 2020 through November 30, 2022; and

WHEREAS the parties also wish to further amend the Agreement to increase the "Not to Exceed" amount commensurately;

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

1. Section 3.1 of the agreement, governing Term, is amended to read as follows:
2. Subject to compliance with all terms and conditions, the term of this Agreement shall be from October 1, 2020 through November 30, 2022.
3. Exhibit B, Section VIII, is amended to read as follows:  
  
Total payments for services performed under this Agreement will not exceed SEVEN HUNDRED TEN THOUSAND DOLLARS (\$ 710,000.00).
4. **All other terms and conditions of the agreement, including any and all previous amendments, between the County and Contractor shall remain in full force and effect.**
