**RESOLUTION AUTHORIZING THE CONTROLLER TO CONTINUE PAYMENTS ON
CERTAIN COUNTY HEALTH CONTRACTS FROM JULY 1, 2021 THROUGH
DECEMBER 31, 2021.**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, each of the agreements with the contractors listed in Attachment A, incorporated by reference herein, expired on or before June 30, 2021, and negotiation for the services covered by these agreements is pending; and

WHEREAS, absent action by this Board, the Controller lacks authority to make payments to the contractors providing services under these agreements between their respective expiration dates and the time at which extensions or new agreements for these services are executed; and

WHEREAS, this Board wishes to authorize the Controller to continue making payments to the contractors listed in Attachment A, through December 31, 2021 pending execution of extensions or new agreements, in amounts not to exceed those set forth for each contractor in Attachment A and at the currently existing rates as set forth in the most recent agreements between the contractors and the County.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that this Board authorizes the Controller to continue making payments to contractors through

December 31, 2021, on the agreements listed in Attachment A for and on behalf of the County, in amounts not to exceed those set forth in Attachment A, subject to the contractors' continued compliance with all terms and conditions of these agreements, with the exception of the maximum payment term provision, and said payments are to be in the amounts authorized by the Chief of San Mateo County Health or designee at the currently existing rates as set forth in the most recent agreements with the County.
