**RESOLUTION SETTING TUESDAY, JUNE 9, 2026, AT 9:15 A.M. AT THE
REGULARLY SCHEDULED BOARD OF SUPERVISORS MEETING AS THE TIME
AND PLACE FOR A PUBLIC HEARING ON THE FILING OF THE GARBAGE AND
RECYCLABLES COLLECTION SERVICE CHARGES REPORT FOR COUNTY
SERVICE AREA NO. 8 (CSA-8, NORTH FAIR OAKS) FOR FISCAL YEAR 2026-27**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, acting as the Governing Board of San Mateo County Service Area No. 8, that

WHEREAS, on January 14, 2025, the Board adopted Resolution No. 080851, setting the garbage and collection rates for County Service Area No. 8 (CSA-8), which took effect July 1, 2025, for those properties that pay for garbage and collection services via the County tax roll; and

WHEREAS, the County pays Recology for residential dwelling garbage services in CSA-8 by collecting fees from property owners, based on the required minimum residential garbage service levels for the property, as outlined in County Ordinance Code 4.04.220; and

WHEREAS, San Mateo County Ordinance Code Sections 4.04.200 through 4.04.330 require that garbage and recyclables collection service charges in CSA-8 be collected on the tax roll in accordance with the amounts shown for each parcel of real

property receiving such service as shown in a written report filed with the Clerk of the Board; and

WHEREAS, San Mateo County Ordinance Code Section 4.04.260 requires that notice of the filing of said written report, and the time and place of a hearing thereon, be published once a week for two successive weeks prior to the date set for the hearing in a newspaper of general circulation in CSA-8.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1. Tuesday, June 9, 2026, at 9:15 a.m., at the regularly scheduled Board of Supervisors meeting, is hereby fixed as the time and place of the hearing on the filing of the fiscal year (FY) 2026-27 Garbage and Recyclables Collection Service Charges Report for County Service Area No. 8 with the Clerk of the Board. On the date of the public hearing, the data for the relevant tax rate area to be utilized in development of the Charges Report will not yet be finalized by the County; therefore, the Charges Report may be revised to reflect any parcel updates received from the County Assessor and/or County Controller on or after June 9, 2026. This meeting of the San Mateo County Board of Supervisors will be held in Chambers. Members of the public may be heard on this matter by attending the meeting in person, by attending remotely via Zoom, or by submitting a written statement to the Clerk of the Board. The June 9, 2026 Board agenda will include information on how to attend the meeting in-person or via Zoom, and will be

2. The Director of the Sustainability Department shall cause a copy of the "NOTICE OF PUBLIC HEARING", to be published once a week for two successive weeks prior to the date set for the public hearing in a newspaper of general circulation in CSA-8.
