#### Second Amendment to Agreement Between the County of San Mateo and California Advanced Imaging Medical Associates, Inc. for Radiology Services

THIS SECOND AMENDMENT TO THE AGREEMENT, is effective and entered

into upon the date last executed below, by and between the COUNTY OF SAN

MATEO, hereinafter called "County," and California Advanced Imaging Medical

Associates, Inc., hereinafter called "Contractor";

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for radiology services for the term of April 1, 2022 through March 31, 2025, in an amount not to exceed \$10,215,000.00 (the "Agreement"); and

WHEREAS, the parties entered into a first amendment to the Agreement to increase the "not to exceed amount" of the Agreement by \$25,000.00 to an amount not to exceed \$ 10,240,000.00; and

WHEREAS, the parties desire to extend the term of the Agreement by two months for the term April 1, 2022 through May 31, 2025 to facilitate ongoing negotiations and increase the "not to exceed amount' of the Agreement by \$ 567,342.00 with no change to the compensation terms of the Agreement

## NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. **EXHIBIT B** (entitled **PAYMENTS**), Section IV. is amended to read as follows:

Total payment for services under this Agreement will not exceed TEN MILLION EIGHT HUNDRED SEVEN THOUSAND THREE HUNDRED FORTY-TWO DOLLARS (\$ 10,807,342.00).

2. Section 3.1 (entitled "<u>Term</u>") is hereby amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from April 1, 2022 through May 31, 2025. Each consecutive 12-month period within the term of this Agreement beginning with the first day of this term shall constitute a "Contract Year", and any period of less than a Contract Year at the end of the term shall be treated pro rata for purposes of Contract Year services and compensation.

# 3. All other terms and conditions of the Agreement shall remain in full force and effect.
