RESOLUTION AUTHORIZING A TENTH AMENDMENT TO THE AGREEMENT WITH TYLER TECHNOLOGIES, INC. (FORMERLY SOCRATA INC.), FOR CONTINUED USE OF SOCRATA OPEN DATA PLATFORM, EXTENDING THE TERM THROUGH JUNE 30, 2024, AND INCREASING THE AMOUNT BY \$123,711 FOR A NEW NOT TO EXCEED AMOUNT OF \$2,581,892.84

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, on February 8, 2013, the County entered into an agreement with Socrata, Inc. for \$52,372 for an Open Data application; and

WHEREAS, on June 18, 2013, amendment no. 1 was executed to increase the contract amount by \$359,856, and to extend the term through June 30, 2015; and

WHEREAS, on June 16, 2015, amendment no. 2 was executed to increase the contract amount by \$413,119.92, and to extend the term through June 30, 2017; and

WHEREAS, on June 17, 2016, amendment no. 3 was executed to add consulting services for the redesigning of the County's Measure A Dashboard, and to increase the contract amount by \$1,600, for a new not to exceed amount of \$826,947.92; and

WHEREAS, on July 20, 2016, amendment no. 4 was executed to procure software subscription licensing and support for Contractor's Perspectives platform, and to increase the contract amount by \$22,200 for a new not to exceed amount of \$849,147.92.

WHEREAS, on June 26, 2017, amendment no. 5 was executed to increase the contract amount by \$444,583.92, for a new not to exceed amount of \$ 1,293,731.84 and to extend the term through June 30, 2019; and

WHEREAS, on June 25, 2019, amendment no. 6 was executed to increase the contract amount by \$420,000.00 for a new not to exceed amount of \$1,713,731.84, and to extend the term through June 30, 2021; and

WHEREAS, on June 8, 2021, amendment no. 7 was executed to increase the contract amount by \$420,000, for a new not to exceed amount of \$2,133,731.84, and to extend the term through June 30, 2023, with an option to extend the term through June 30, 2024; and

WHEREAS, on June 13, 2023, amendment no. 8 was executed to increase the contract amount by \$216,300 for a new not to exceed amount of \$2,350,031.84, and to extend the term through June 30, 2024; and

WHEREAS, on June 25, 2023, amendment no. 9 was executed to increase the contract amount by \$108,150 for a new not to exceed amount of \$2,458,181.84, and to extend the term through December 31, 2024; and

WHEREAS, the parties wish to amend the Agreement to increase the amount by \$123,711, for a new not to exceed amount of \$2,581,892.84 in order to continue to use of the Socrata Connected Government Cloud (also referred to as the Enterprise Data Platform) Program Edition, and extend the term through June 30, 2025.

WHEREAS, this Board has been presented with form of such agreement and has examined and approved it as to both form and content and desires to enter the agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board of Supervisors is hereby authorized and directed to execute said agreement for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest to the President's signature thereto.

BE IT FURTHER RESOLVED that the Director/Chief Information Officer (CIO) or their designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term of services is/are within the current or revised fiscal provisions.
