*WHEREAS, CHRISTINA CORPUS is honored for her continuous and extensive advocacy and leadership in the area of intimate partner violence; and*

*WHEREAS, CHRISTINA CORPUS serves the San Mateo County Sheriff's Office as Captain with Area Command Responsibilities and leads four patrol teams, a community policing team and oversees the youth outreach program; and*

*WHEREAS, CHRISTINA CORPUS has significantly contributed to the prevention of intimate partner violence over the 25 years she has been in law enforcement; and*

*WHEREAS, CHRISTINA CORPUS in the early stages of mandatory shelter-in-place, noticed an increase of domestic violence in her area. She created educational flyers and posters in English and Spanish indicating that the home may not be safest environment and provided instructions with where and how to reach out; and*

*WHEREAS, CHRISTINA CORPUS organized several Zoom bilingual workshops on domestic violence during COVID with the unique situation of the aggressor being in the home and the resources for where and how to receive help; and*

*WHEREAS, CHRISTINA CORPUS continues her work with CORA in training staff and in educating the public, especially youth, around intimate partner violence. Captain Corpus strongly believes that bringing education to youth will significantly stop the cycle of domestic violence; and*

*WHEREAS, in the footsteps of Lieutenant Barbara Hammerman, CHRISTINA CORPUS has distinguished herself by providing exemplary service and devout dedication to the prevention of intimate partner violence.*
