RESOLUTION AUTHORIZING A GRANT AGREEMENT WITH DALY CITY PARTNERSHIP TO SUPPORT YOUTH AFTER SCHOOL PROGRAMMING AND COMMUNITY MENTAL HEALTH SERVICES IN NORTHERN SAN MATEO COUNTY, FOR THE TERM JANUARY 28, 2025 THROUGH JANUARY 27, 2028, IN AN AMOUNT NOT TO EXCEED \$750,000 AND AUTHORIZING THE COUNTY EXECUTIVE, OR DESIGNEE, TO EXECUTE THE AGREEMENT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Measure K is the half-cent general sales tax initially approved by San Mateo County voters in November 2012, and extended in November 2016 for total of thirty years; and

WHEREAS, Daly City Partnership's (DCP) mission is to create transformative change by providing comprehensive, multi-generational services that empower children, families, and older adults to overcome challenges and promote community advancement; and

WHEREAS, DCP has seen a more than 50 percent rise over the past four years in the number of individuals and families the organization serves with over 14,500 individuals being served in fiscal year 2023-24; and

WHEREAS, DCP reports that approximately \$1.2 million in funding has been cut or is at risk of being cut due to the expiration of COVID-19 relief funds and shifts in the education and nonprofit funding landscape; and

WHEREAS, DCP requested Measure K funds to support essential youth and family services, as well as mental health programs that have been significantly impacted by funding reductions; and

WHEREAS, the term of the agreement is January 28, 2025 to January 27, 2028, for a total amount not to exceed \$750,000; and

WHEREAS, this Board has been presented with the form of the grant agreement and has examined it and approved it as to both form and content and desires to enter into the agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors approves of said grant, and authorizes the County Executive or designee to execute said grant agreement for and on behalf of the County of San Mateo.

BE IT FURTHER RESOLVED that the County Executive or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified contract term or services is/are within the current or revised fiscal provisions.
