RESOLUTION AUTHORIZING THE CHIEF OF SAN MATEO COUNTY HEALTH OR THEIR DESIGNEE TO EXECUTE AGREEMENTS WITH THE ELIGIBLE VENDORS LISTED IN ATTACHMENT A TO PROVIDE CONTINGENCY STAFFING SERVICES FOR THE PERIOD OF JUNE 28, 2025 THROUGH JULY 1, 2028 IN AN AMOUNT NOT TO EXCEED \$12,000,000 IN AGGREGATE

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Health Information Technology division (HIT) provides many types of Information Technology support and services to County Health divisions including both operational and project support; and

WHEREAS, HIT released a Request for Proposals in February of 2025 for Contingency staffing services to create an eligible list of pre-approved vendors qualified to provide the services described therein; and

WHEREAS, County Health is requesting authorization to select from the preapproved vendor lists to meet a variety of contingency staffing needs, allowing County Health to choose a vendor from the Attachment A list, and authorizing the Chief of San Mateo County Health or their designee to execute agreements, for contingency staffing services throughout the term of June 28, 2025 through July 1, 2028 in an amount not to exceed \$12,000,000, in the aggregate; and

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the

Chief of San Mateo Health or their designee is hereby authorized to execute agreements with the vendors listed on Attachment A, for contingency staffing services for the term of June 28, 2025 through July 1, 2028 in an amount not to exceed \$12,000,000, in aggregate.
