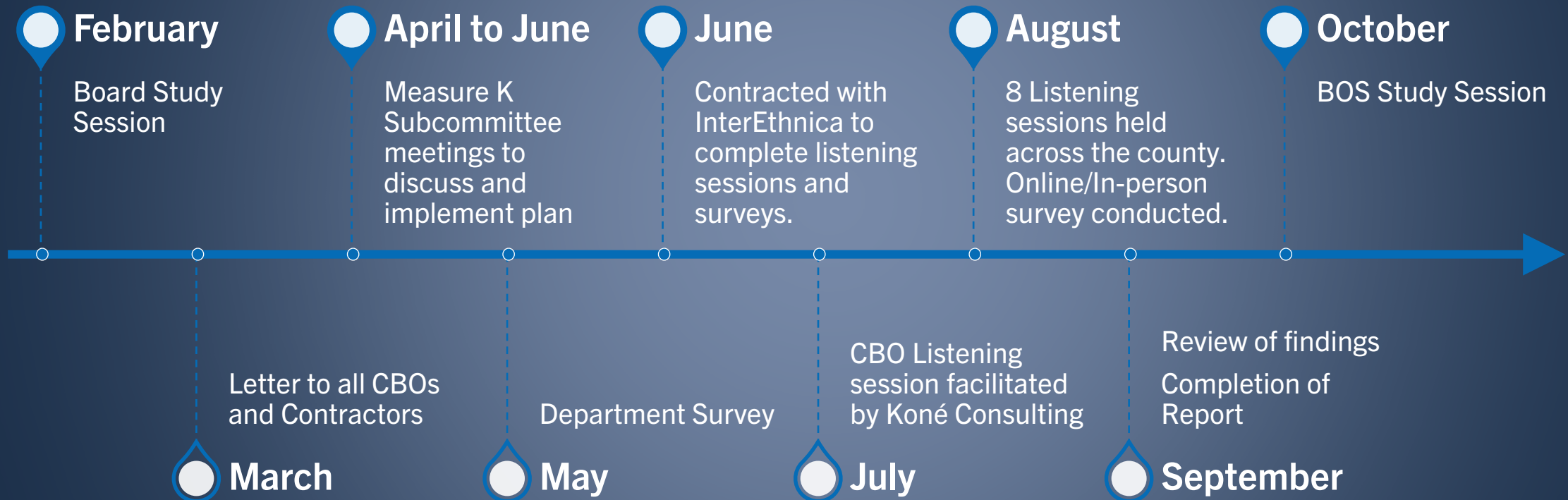

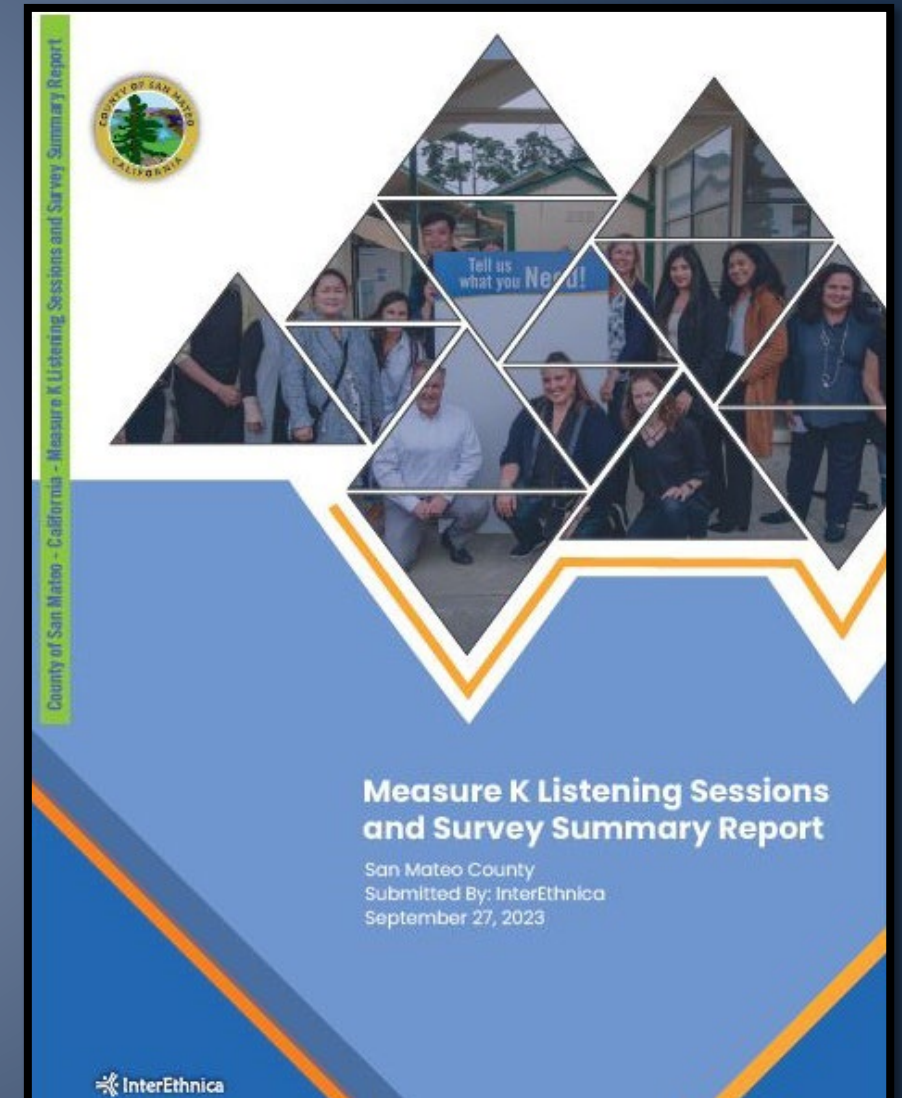

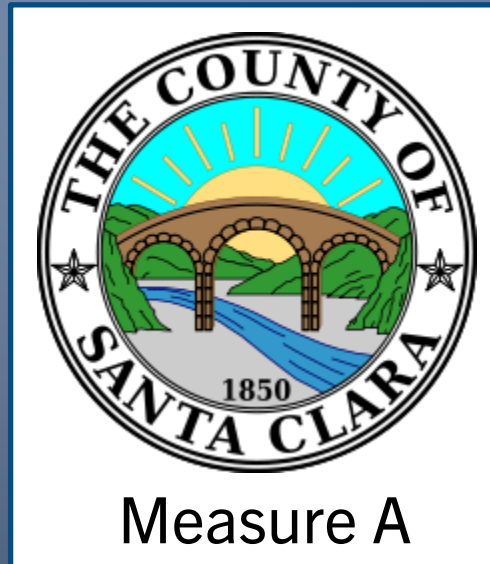


NOFO divided by BOS Priority Area:

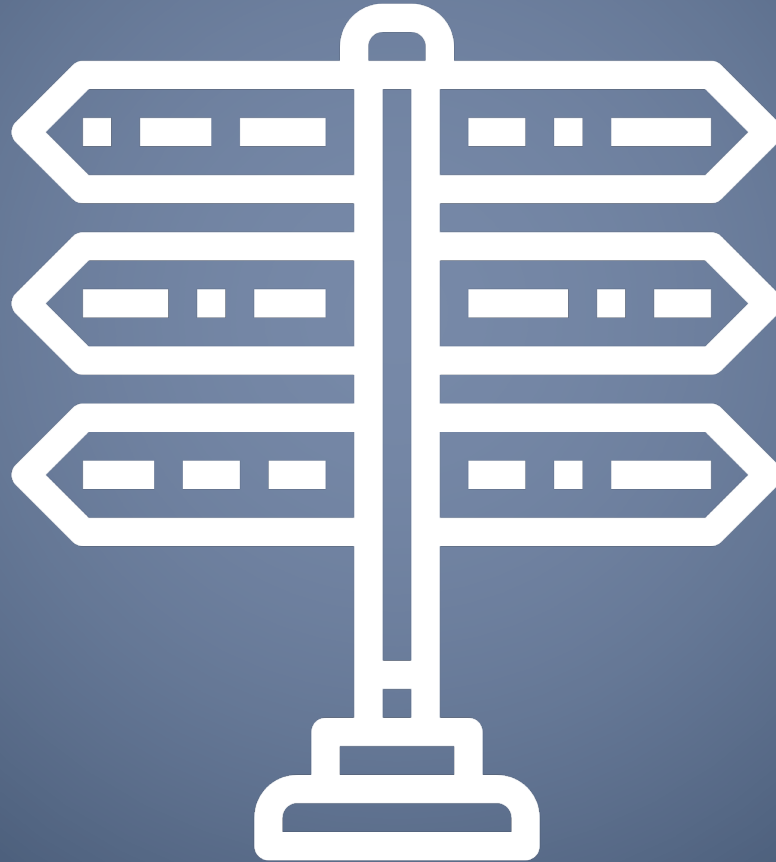

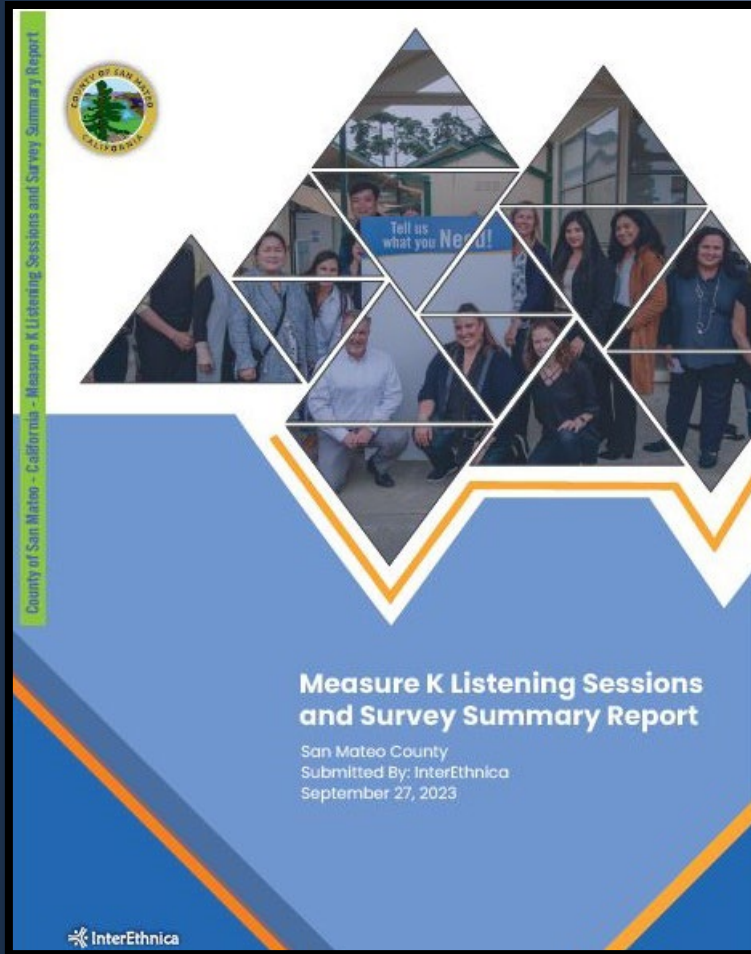

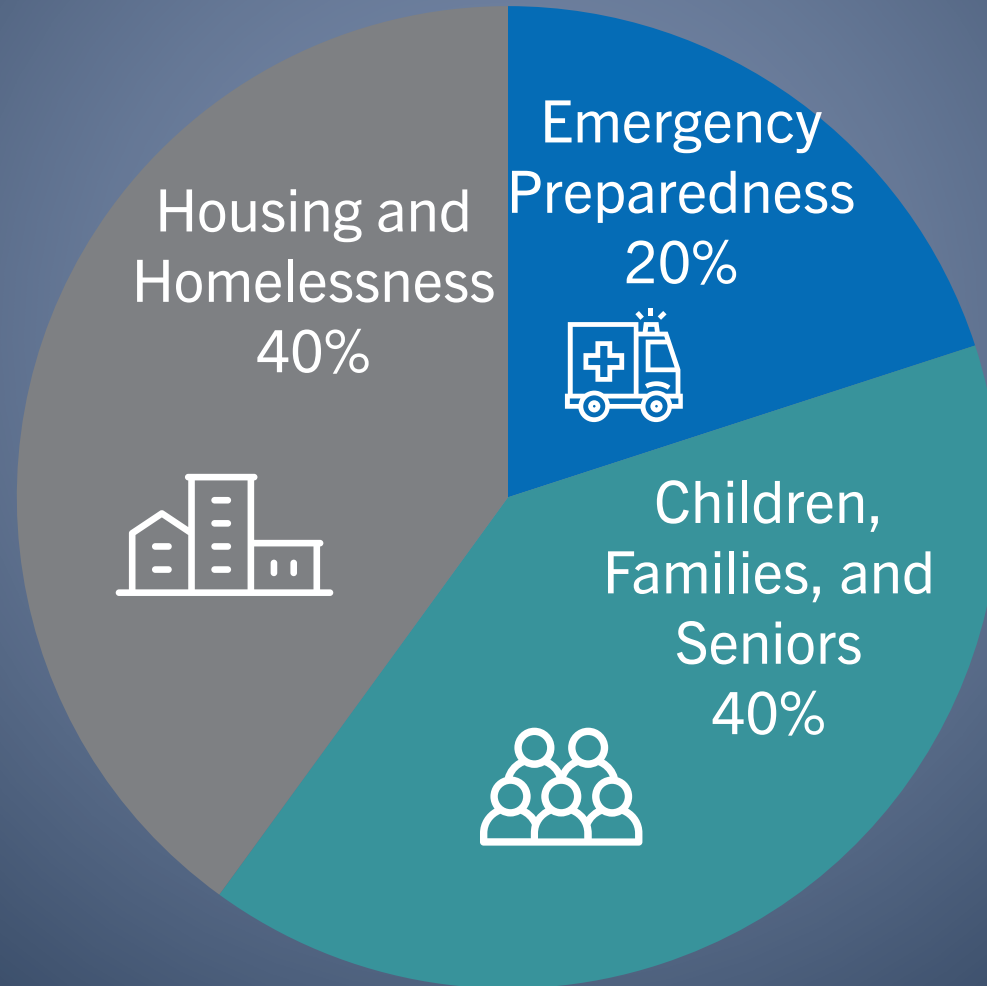
