**RESOLUTION AUTHORIZING TWO APPLICATIONS TO THE METROPOLITAN
TRANSPORTATION COMISSION THROUGH CITY AND COUNTY ASSOCIATION
OF GOVERNMENTS FOR THE SAFE AND SEAMLESS MOBILITY QUICK-STRIKE
COMPETITIVE GRANT PROGRAM FOR PEDESTRIAN AND BICYCLE
IMPROVEMENT PROJECTS ON COLEMAN AVENUE IN UNINCORPORATED
MENLO OAKS AND ON 87TH STREET AND SOUTH PARK PLAZA DRIVE IN
UNINCORPORATED BROADMOOR**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Metropolitan Transportation Commission (MTC) provides funding to support its commitments to regional transportation priorities which advancing the Bay Area’s land use and housing goals; and

WHEREAS, the Safe and Seamless Mobility Quick-Strike program is a one-time competitive grant program within the One Bay Area Grant program (OBAG 2) framework; and

WHEREAS, the County of San Mateo Department of Public Works (Department) has identified two roadway improvement projects which meet the criteria for Communities of Concern:

- (1) Coleman Avenue Road Improvements in unincorporated Menlo Oaks; and
- (2) Various intersections in unincorporated Broadmoor

to improve safety for drivers, bicyclists, and pedestrians; and

WHEREAS, the Sponsor will:

(1) work with the community to develop conceptual plans for a Coleman Avenue Road Improvement Project to improve bicycle and pedestrian access; and,

(2) construct the Broadmoor Safe Routes to School Improvements Projects (Projects) to increase visibility, provide crosswalk improvements, curb extensions, and ramps that meet current Americans with Disability Act (ADA) standards; and

WHEREAS, estimated grant amounts of

(1) \$914,000 to implement the Coleman Avenue Improvement Project scope and

(2) \$1,603,000 to implement Broadmoor Safe Routes to School Improvement Project; and

WHEREAS, the Department is seeking full funding for the Projects; and

WHEREAS, the Metropolitan Transportation Commission (MTC) issued a Call for Projects for the Quick-Strike Program on February 8, 2021; and

WHEREAS, the Metropolitan Transportation Commission requires a governing board resolution from the Department for the following items:

1. Supporting two applications of \$914,000 and \$1,603,000 in MTC Quick Strike Program; and
2. Committing the Sponsor to the completion of the projects; and
3. Certifying that any funds awarded by the MTC will be used to supplement existing funds for program activities and not replace existing funds or resources; and
4. Authorizing the chief executive of the Sponsor, or designee, to sign a

funding agreement with the MTC, if funds are awarded, for MTC Quick-Strike program funding for the projects and to take any other actions necessary to give effect to this resolution.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors:

1. Directs the County of San Mateo Department of Public Works to submit two applications for MTC Quick-Strike Program funds for \$914,000 to implement the Coleman Avenue Road Improvement Project for the development conceptual plans and \$1,603,000 to construct improvements for the Broadmoor Safe Routes to School Project.
2. Authorizes the Public Works Director, or designee, to execute a funding agreement with the San Mateo County Transportation Authority to encumber any MTC Quick-Strike Program funds awarded.
3. Commits to the completion of the Project, if awarded the requested MTC funds.
4. Certifies that any funds awarded by the Metropolitan Transportation Commission will be used to supplement existing funds for program activities and will not replace existing funds or resources.
5. Take any other actions necessary to give effect to this resolution.
