WHEREAS, the County of San Mateo Jobs for Youth program fundraises throughout the fiscal year for the Al Teglia Scholarship and provides 20 youth with \$2,000 each toward their higher education goals each May, with priority for Scholarship awards given to low-income youth who have overcome hardship; and

WHEREAS, individuals, businesses, city councils, and foundations donate taxdeductible funds to the Scholarship throughout the fiscal year; and

WHEREAS, the City of Menlo Park provided a \$4,000 monetary contribution, the Town of Colma provided a \$4,000 monetary contribution, the Sares Regis

Foundation provided a \$4,000 monetary contribution, the Pacific Gas & Electric

Company provided a \$8,000 monetary contribution, and the Woodlawn Foundation provided a \$10,000 monetary contribution; and

WHEREAS, the 20 Jobs for Youth 2024 Al Teglia Scholars will use the funds to support enrollment in college or vocational training programs and will redeem the first

\$1,000 of the monies upon enrollment and the second \$1,000 upon completion of college-level or vocational coursework within two years of winning the award; and

WHEREAS, the Board of Supervisors of San Mateo County supports this endeavor to increase educational opportunities for youth in need.

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors of San Mateo County accepts the monetary donations supporting the Jobs for Youth Al Teglia Scholarship program on behalf of the County of San Mateo.

BE IT FURTHER RESOLVED that the Board of Supervisors thanks each and every donor for their support of the County of San Mateo Jobs for Youth Al Teglia Scholarship program.
