RESOLUTION AUTHORIZING AN AGREEMENT WITH THE COUNTY OF SANTA CLARA OFFICE OF THE DISTRICT ATTORNEY TO FUND THE SALARY AND BENEFITS OF A LEAD CRIME ANALYST ASSIGNED TO THE NORTHERN CALIFORNIA REGIONAL INTELLIGENCE CENTER, FOR A TERM COMMENCING SEPTEMBER 1, 2019 THROUGH JANUARY 31, 2020, IN AN AMOUNT NOT TO EXCEED \$60,000

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County of San Mateo and the County of Santa Clara Office of the District Attorney (SCCO DA) are engaged in collaborative efforts to share information and coordinate investigations targeting the most prolific and violent criminals in the community and identifying terrorist threats; and

WHEREAS, as part of these efforts, the Northern California Regional Intelligence Center (NCRIC) collaborates with the SCCO DA's Crime Strategies Unit (CSU) to investigate and pursue leads that will prevent or disrupt terrorism and other significant criminal activity; and

WHEREAS, as part of this collaboration, the SCCO DA applied for and was awarded 2017 United States Department of Homeland Security Grant Program funds through the State of California Office of Emergency Services to fund the salary and benefits of a NCRIC lead crime analyst for their Crime Strategies Unit (CSU); and

WHEREAS, the NCRIC entered into an agreement with the SCCO DA for these funds, which was approved by this Board on December 4, 2018 through Resolution No. 076315 and fully expended in September 2019; and

WHEREAS, the SCCO DA has agreed to utilize \$60,000 of Regional Enforcement Allied Computer Team (REACT) funds to fund the salary and benefits of the lead crime analyst assigned to the NCRIC from September 1, 2019 through January 31, 2020; and

WHEREAS, this Board has been presented with the agreement with the County of Santa Clara Office of the District Attorney and has examined and approved it as to both form and content and desires to enter into the same; and

NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board of Supervisors be and is hereby authorized and directed to execute the agreement with the County of Santa Clara Office of the District Attorney for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Sheriff or Sheriff's designee is hereby authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$15,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
