RESOLUTION ACKNOWLEDGING RECEIPT OF THE CALIFORNIA COASTAL COMMISSION'S CONDITIONAL CERTIFICATION OF THE COUNTY'S LOCAL COASTAL PROGRAM (LCP) AMENDMENTS FOR THE PESCADERO FIRE STATION REPLACEMENT AND COUNTY SERVICE AREA NO. 11 (CSA-11) WATERLINE EXTENSION, INCORPORATING THE COASTAL COMMISSION'S MODIFICATIONS, AND DIRECTING SUBMITTAL OF THE MODIFIED LCP AMENDMENTS TO THE EXECUTIVE DIRECTOR OF THE CALIFORNIA COASTAL COMMISSION FOR REVIEW

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, in November 2022 the Board of Supervisors approved resolutions directing staff to submit a package of amendments to the County's Local Coastal Plan that will enable the extension of CSA-11 water lines to the Pescadero Middle/High School and permit the construction of the replacement Fire Station No. 59 on land adjacent to the school; and

WHEREAS, the adopted amendments were subsequently submitted to the California Coastal Commission ("Coastal Commission") for the Commission's review and certification, as required by the Coastal Act; and

WHEREAS, the California Coastal Commission considered the proposed amendments on December 15, 2023, and conditionally certified the amendments, contingent on modifications to proposed Policy 2.60 and the footnotes for Table 2.16; and

WHEREAS, in order for the conditionally certified amendments to take effect, the Board of Supervisors must accept, agree, and adopt the Coastal Commission's suggested modifications; and

WHEREAS, the Board of Supervisors wishes to adopt the suggested modifications by this resolution.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

The Board of Supervisors acknowledges receipt of the California Coastal Commission's resolution of certification LCP-2-SMC-23-0002-1, including suggested modifications to proposed LCP Policy 2.60 and Table 2.16, and hereby adopts these modifications.

BE IT FURTHER RESOLVED that the Board of Supervisors agrees that any issuance of coastal development permits subject to the amended Local Coastal Program policies, as adopted by resolution, shall incorporate the Coastal Commission's suggested modifications.

BE IT FURTHER RESOLVED that Planning and Building Department staff are directed to submit said resolution to the Executive Director of the California Coastal Commission for review of legal adequacy.
