RESOLUTION AUTHORIZING THE ESTABLISHMENT OF "TIME LIMITED PARKING" ZONES ON MIDDLEFIELD ROAD AND ASSOCIATED SIDE STREETS FROM PACIFIC AVENUE TO FIFTH AVENUE AS NEEDED DURING THE CONSTRUCTION OF THE MIDDLEFIELD ROAD IMPROVEMENT PROJECT IN NORTH FAIR OAKS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507 et al. and Sections
7.24.010 and 7.28 of the County Ordinance Code allow the Board of Supervisors to set
time limited parking zones and prohibit or restrict the stopping, parking or standing of
vehicles by resolution or ordinance; and

WHEREAS, the Director of Public Works has recommended that "Time Limited Parking" Zones be established temporarily to alleviate the loss of parking along Middlefield Road as noted herein and in connection with the construction of the Middlefield Road Improvement Project (Project); and

WHEREAS, the Project includes work adjacent to businesses for prolonged periods of time affecting parking in front of businesses; and

WHEREAS, establishing temporary limited term parking in specific areas during construction of the Project may be beneficial in specific locations to help ensure customer parking is available at convenient places near customer-serving locations along the Project corridor; and

WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

IT IS FURTHER DETERMINED AND ORDERED that:

- 1. Temporary "Time Limited Parking" Zones may be established by the Director of Public Works as deemed necessary in the time limited parking durations as defined by County Ordinance Code to within the following locations:
 - a) Middlefield Road (Road 29B), unincorporated North Fair Oaks, from approximately the north side of Pacific Avenue to the south side of 5th Avenue on both sides of Middlefield Road for 0.44 miles (2,325 feet) more or less.
 - b) Pacific Avenue (Road 446), unincorporated North Fair Oaks, approximately one hundred (100) feet south of the centerline of Middlefield Road, on both sides of Pacific Avenue continuing northerly for sixty feet (60') feet more or less.
 - c) Dumbarton Avenue (Road 387B), unincorporated North Fair Oaks, approximately one hundred (100) feet south of the centerline of Middlefield Road, on both sides of Dumbarton Avenue continuing northerly for sixty feet (60') feet more or less.
 - d) Dumbarton Avenue (Road 387B), unincorporated North Fair Oaks, approximately one hundred (100) feet north of the centerline of Middlefield Road, on both sides of Dumbarton Avenue continuing southerly for sixty feet (60') feet more or less.
 - e) Berkshire Avenue (Road 390B), unincorporated North Fair Oaks, approximately one hundred (100) feet south of the centerline of

- Middlefield Road, on both sides of Berkshire Avenue continuing northerly for sixty feet (60') feet more or less.
- f) First Avenue (Road 449), unincorporated North Fair Oaks, approximately one hundred (100) feet south of the centerline of Middlefield Road, on both sides of First Avenue continuing northerly for sixty feet (60') feet more or less.
- g) First Avenue (Road 449), unincorporated North Fair Oaks, approximately one hundred (100) feet north of the centerline of Middlefield Road, on both sides of First Avenue continuing southerly for sixty feet (60') feet more or less.
- h) Second Avenue (Road 455B), unincorporated North Fair Oaks, approximately one hundred (100) feet south of the centerline of Middlefield Road, on both sides of Second Avenue continuing northerly for sixty feet (60') feet more or less.
- i) Second Avenue (Road 455A), unincorporated North Fair Oaks, approximately one hundred (100) feet north of the centerline of Middlefield Road, on both sides of Second Avenue continuing southerly for sixty feet (60') feet more or less.
- j) Third Avenue (Road 479A), unincorporated North Fair Oaks, approximately one hundred (100) feet south of the centerline of Middlefield Road, on both sides of Third Avenue continuing northerly for sixty feet (60') feet more or less.
- k) Third Avenue (Road 479A), unincorporated North Fair Oaks, approximately one hundred (100) feet north of the centerline of

- Middlefield Road, on both sides of Third Avenue continuing southerly for sixty feet (60') feet more or less.
- I) Fourth Avenue (Road 543A), unincorporated North Fair Oaks, approximately one hundred (100) feet south of the centerline of Middlefield Road, on both sides of Fourth Avenue continuing northerly for sixty feet (60') feet more or less.
- m) Fourth Avenue (Road 543A), unincorporated North Fair Oaks, approximately one hundred (100) feet north of the centerline of Middlefield Road, on both sides of Fourth Avenue continuing southerly for sixty feet (60') feet more or less.
- n) Fifth Avenue (Road 23), unincorporated North Fair Oaks, approximately one hundred (100) feet south of the centerline of Middlefield Road, on both sides of Fifth Avenue continuing northerly for sixty feet (60') feet more or less.
- o) Fifth Avenue (Road 23), unincorporated North Fair Oaks, approximately one hundred (100) feet north of the centerline of Middlefield Road, on both sides of Fifth Avenue continuing southerly for sixty feet (60') feet more or less.
- The Department of Public Works is authorized and directed to post any
 necessary temporary signs with the specified dates and times of the
 restrictions 24 hours in advance during the construction of the Middlefield
 Road Improvement Project.
