

DEPARTMENT UPDATE

San Mateo County Parks Commission October 2, 2025

Visitor Experience

Interpretive Events

From July to August 2025, the Interpretive Division hosted or participated in 32 programs, serving approximately 3699 people (3000 is the approximate number of attendees at Summerfest at Coyote Point). Highlights included offering 2 Junior Naturalist Day Camps at Fitzgerald Marine Reserve and 5 Youth Camping Weekends at Memorial Park with local community organizations. In partnership with the Parks Foundation, SMC Health, and Friends of Huddart and Wunderlich, we also offered field trips to several senior centers. For these groups, we offer short hikes, arts and crafts, and tours of the visitor centers. The details of interpretive programs are included in this report as Attachment 1.

The Interpretive Division hosted Fallfest at Flood Park on September 20. This free community celebration included sports clinics for youth, a Zumba class, several community resource booths, and an arts and crafts area. Approximately 300 people attended this event. This was our second Fallfest event, but the first time it was hosted at Flood Park. Moving forward, we anticipate hosting Springfest at Quarry Park, Summerfest at Coyote Point, and Fallfest at Flood Park.

Volunteer Events

From July to August 2025, the Volunteer Program hosted 25 volunteer events throughout the parks system. These events totaled 1852 hours of volunteer effort supporting and improving the parks. The details of each event are included in this report as Attachment 2.

Facilities and infrastructure

Don Horsley County Park at Tunitas Creek Beach

Completion of Don Horsley County Park at Tunitas Creek Beach is delayed due to landslides near the beach emergency access route. This must be remediated before the park can safely open. As a result, the new expected opening is anticipated for summer 2026.

Realize Flood Park

Following completion of Phase 1 of the Realize Flood Park Project, the reservation system opened for the updated group picnic areas, which accommodate between 40 to 200 people. Construction on the playground continues, with a projected opening date of Summer 2026.

San Bruno Mountain Day Use Improvement Project

The restroom and interpretive pavilion are nearly complete, and work is underway on the picnic sites. The completed project will provide 4 gender neutral ADA restroom stalls, an open-air interpretive pavilion with educational panels and photo displays, and 9 picnic sites accommodating groups between 8-32 people. A projected opening date is mid-November 2025.

Natural Resource Management

Wildfire Mitigation Projects

The Natural Resource Management Division has been overseeing and planning wildfire mitigation projects to reduce fire fuels in various county parks. In September and October, trails adjacent to the Crocker Gate entrance at San Bruno Mountain State & County Park will be intermittently closed as crews work to create a shaded fuel break. A 12-acre shaded fuel break project was completed at Junipero Serra County Park in mid-September, in areas adjacent to park boundaries. A forest health and fuel reduction project at Pescadero Creek County Park will begin in late September and continue through the end of the year.
