**RESOLUTION AUTHORIZING A SECOND AMENDMENT TO THE AGREEMENT WITH ABODE SERVICES FOR HOUSING AND DISABILITY ADVOCACY PROGRAM (HDAP) RAPID RE-HOUSING AND SHALLOW SUBSIDY SERVICES, TO EXTEND THE TERM BY ONE YEAR FOR A REVISED TERM OF JULY 1, 2024 THROUGH JUNE 30, 2027, AND TO ADD \$352,393 IN FUNDS FOR A REVISED TOTAL AMOUNT NOT TO EXCEED \$1,534,113**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS** the Human Services Agency (HSA) coordinates homeless services throughout the County of San Mateo and rapid re-housing services (RRH) is one key component of the homeless crisis response system; and

**WHEREAS**, on March 13, 2024, HSA issued a Request for Proposals for RRH and shallow subsidy services where an evaluation was conducted of all the proposals received and the review panel recommended Abode Services for RRH and shallow subsidy services; and

**WHEREAS**, on June 25, 2024, by Resolution No. 080537, this Board authorized the County of San Mateo to execute an agreement with Abode Services for HDAP rapid re-housing and shallow subsidy services for an amount not to exceed \$609,744 and a term of July 1, 2024 through June 30, 2025; and

**WHEREAS**, on June 10, 2025, by Resolution No. 081266, this Board authorized the County of San Mateo to execute an amendment to the agreement with Abode Services for HDAP RRH and shallow subsidy services for a revised total amount

not to exceed \$1,181,719 and an extended term of July 1, 2024 through June 30, 2026;  
and

**WHEREAS**, in November 2025, the California Department of Social Services (CDSS) announced HDAP funding for Fiscal Year 2022-23 with an expenditure deadline of June 30, 2028; and

**WHEREAS**, In December 2025, HSA accepted \$416,001 in non-competitive awards for HDAP expenditures from CDSS through June 30, 2028, which HSA uses across its three HDAP contracts; and

**WHEREAS** HSA requests to amend the agreement with Abode Services to increase funding by \$352,393 for a new total obligation amount not to exceed \$1,534,113, and to extend the contract term one year through June 30, 2027.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of this Board of Supervisors be and is hereby authorized and directed to execute said amendment for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Director of the Human Services Agency or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in the aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
