RESOLUTION AUTHORIZING A FIFTH AMENDMENT TO THE AGREEMENT WITH ECOLOGY ACTION FOR CONSULTING SERVICES RELATED TO THE SAN MATEO COUNTY GREEN BUSINESS PROGRAM, INCREASING THE AMOUNT BY \$210,000 FOR A NEW NOT TO EXCEED AMOUNT OF \$733,091

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the Office of Sustainability contracted with Ecology Action in 2017 to provide services related to the San Mateo County Green Business Program, including recruitment, certification, and marketing support; and

WHEREAS, the Green Business Program is valuable because it helps small and medium local businesses minimize their environmental impacts; and

WHEREAS, The Green Business Program certifies small and medium size businesses that complete a set of measures related to reducing greenhouse gas emissions, conserving energy, minimizing waste, and preventing air and water pollution, and therefore the Office of Sustainability is interested in growing the Green Business Program, expanding the diversity of businesses served, and providing free services and support to businesses in alignment with recovery efforts; and

WHEREAS, by amending the contract to add additional funds, Ecology Action can continue to provide a high level of service related to coordination of the County's

Green Business Program, recruitment and certification support, and marketing and outreach activities to ensure the Green Business Program is successful, can be responsive to business needs during COVID-19, and will be more inclusive of women and minority owned businesses and businesses in socially vulnerable areas of the County; and

WHEREAS, to support business recovery, increased consumer support of local businesses is needed, and the Green Business Program will develop consumer incentives to shop local and green; and

WHEREAS, to increase participation and reduce barriers to participation, the Office of Sustainability will increase Green Business Services provided in Spanish and continue to partner with community-based organizations to reach traditionally underserved businesses.

NOW THEREFORE, BE IT RESOLVED that the President of the Board of Supervisors shall be and is hereby authorized and directed to execute an amendment to the agreement with Ecology Action for Green Business Program consulting services in an amount not to exceed \$733,091 for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Director of the Office of Sustainability or the Director's designee is authorized to execute subsequent amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
