RESOLUTION 081316 TO DELETE SIX POSITIONS, ADD FIVE POSITIONS, SET
THE SALARY RANGE OF SIX CLASSIFICATIONS, AND RECLASSIFY SIX
POSITIONS; AND ACCEPT THE UPDATED REPORT OF BIWEEKLY SALARIES BY
CLASSIFICATION

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 073703 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 081316 as follows:

SECTION 1: Section 14 of the Resolution is amended as indicated:

25100 DISTRICT ATTORNEY'S OFFICE

- Item G098S, Social Worker/Children's Services Social Worker Series is decreased by 1 for a new total of 1 position.
- 2. Item G099, Forensic Interviewer is increased by 1 for a new total of 1 position.

32000 PROBATION DEPARTMENT

- Item D163, Probation Services Manager I is decreased by 3 for a new total of 14 positions.
- Item D162, Probation Services Manager II is increased by 2 for a new total of 7 positions.

33000 CORONER'S OFFICE

- Item T070, Forensic Autopsy Technician is decreased by 1 for a new total of 2 positions.
- 2. Item T071, Supervising Forensic Autopsy Technician is increased by 1 for a new total of 1 position.

61000 BEHAVIORAL HEALTH AND RECOVERY SERVICES (BHRS)

- Item D033, Health Services Manager II is decreased by 1 position for a new total of 2 positions.
- Item D248, Senior Advisor to the Director of BHRS is increased by 1 position for a new total of 1 position.

- Salary for Item F110, Neurodiagnostic Technician I is set at \$40.24 \$50.30 per hour.
- 2. Salary for Item F111, Neurodiagnostic Technician II is set at \$46.38 \$57.99 per hour.

- 3. Salary for Item F112, Neurodiagnostic Technician III is set at \$50.50 \$63.14 per hour.
- Salary for Item F110-R, Neurodiagnostic Technician I-Relief is set at \$42.25 –
 \$52.82 per hour.
