**RESOLUTION:**

- A) ADOPTING PLANS AND SPECIFICATIONS, INCLUDING CONFORMANCE WITH PREVAILING WAGE SCALE REQUIREMENTS, FOR THE 2026 PAVEMENT PRESERVATION PROJECT; AND**
- B) AUTHORIZING THE PRESIDENT OF THE BOARD TO EXECUTE AN AGREEMENT WITH VSS INTERNATIONAL, INC. IN THE AMOUNT OF \$2,020,120 FOR THE 2026 PAVEMENT PRESERVATION PROJECT; AND**
- C) AUTHORIZING THE DIRECTOR OF PUBLIC WORKS TO:
  - 1. EXECUTE SUBSEQUENT CHANGE ORDERS TO GRANT TIME EXTENSIONS FOR PROJECT COMPLETION AND PAYMENT UP TO A MAXIMUM AGGREGATE AMOUNT NOT TO EXCEED \$202,012, OR APPROXIMATELY 10% OF THE AGREEMENT AMOUNT; AND**
  - 2. EXECUTE PAYMENT UP TO THE NOT TO EXCEED AMOUNT OF \$2,222,132 OF BID FOR ITEMS REQUIRING ADJUSTMENT BASED ON UNIT BID PRICES WITHOUT EXECUTION OF A CHANGE ORDER****

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, this Board adopted Resolution No. 081688 on February 10, 2026, which “streamlined” the bid process for projects to be constructed during the 2026 construction season which are maintenance type projects that do not have long lead times for design, are not considered controversial requiring specific property owner input, and that do not require state or federal grant approvals, that have not previously been approved by this Board, and do not require extensive permit approvals from regulatory agencies by authorizing the Director of Public Works to develop plans and specifications and to call for bids for these types of projects; and

**WHEREAS**, Plans and Specifications, dated May 15, 2026, were prepared and approved by the Director of Public Works for the 2026 Pavement Preservation Project (Project); and

**WHEREAS**, a schedule of prevailing wage scales for each craft or type of worker needed to execute these plans and specifications in the locality in which said work is to be performed has been established by the Department of Industrial Relations and has been referred to in said plans and specifications; and

**WHEREAS**, the Department of Public Works did issue a call for sealed proposals to be received at the office of the County Executive/Clerk of the Board of Supervisors, 500 County Center, 5<sup>th</sup> Floor, Redwood City, California, until the hour of 2:30 p.m., Thursday, June 4, 2026; and

**WHEREAS**, the Department of Public Works did cause the notice inviting sealed proposals to be published two (2) times in the Examiner Peninsula Newspaper, a newspaper printed and published in this County, and obtained an affidavit of said publication; and

**WHEREAS**, the Deputy Clerk of this Board of Supervisors did, in public on June 4, 2026, at 2:30 p.m., open and examine all sealed bids that were received in the specified time for the doing of the work referred to in said Plans and Specifications; and

**WHEREAS**, this Board of Supervisors has caused an analysis of said bids to be made by the Director of Public Works of the County of San Mateo, and has, in open session, fully reviewed and considered said sealed proposals and the analysis thereof; and

**WHEREAS**, the lowest responsible bid was submitted by VSS International Inc., in the amount of \$2,020,120, based on an estimate of the amount of work to be

done; and

**WHEREAS**, the Project complies with the California Environmental Quality Act (CEQA) through the County's Routine Maintenance Program.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** as follows:

1. The plans and specifications dated May 15, 2026, for the aforesaid Project are hereby approved and are adopted as the plans and specifications to be adhered to in letting and performing the work under a contract for said improvements.
2. It is to the best interest of the County of San Mateo to award the agreement for the 2026 Pavement Preservation Project to:

VSS International, Inc.

3. The County of San Mateo shall enter into a written agreement with VSS International, Inc., for the completion of said work as required by the Plans and Specifications adopted by this Board of Supervisors, as hereinbefore mentioned, which Plans and Specifications are on file in the office of the Director of Public Works of the County of San Mateo.
4. The President of this Board of Supervisors shall be, and is hereby, authorized and directed to execute an agreement with VSS International, Inc., for the doing of said work described therein, subject to the Department of Public

Works' receipt and approval of the Faithful Performance Surety Bond ("Performance Bond") and the Labor and Material Surety Bond ("Payment Bond") required to be posted by said Contractor with the County of San Mateo in connection therewith.

5. The Director of Public Works is hereby authorized to execute change orders related to said work for time extensions and payment not exceeding \$202,012 in aggregate.
6. All payments to the Contractor shall be in accordance with the Plans and Specifications, and other agreement documents. Aggregate payment to the Contractor shall not exceed \$2,222,132 without this Board's approval.
7. The Director of Public Works is hereby authorized to approve payments up to the not-to-exceed amount of \$2,222,132 for items requiring adjustment based on unit bid prices without execution of a change order.
8. The Clerk of the Board of Supervisors, County of San Mateo, is hereby authorized and directed to attest the signature of the President of this Board of Supervisors to said written agreement.
