**RESOLUTION AUTHORIZING AN AMENDMENT TO THE AGREEMENT WITH FRESH LIFELINES FOR YOUTH, INC. SECURED THROUGH JUVENILE PROBATION CAMP FUNDING, ADDING \$250,000.00 FOR A REVISED AMOUNT NOT TO EXCEED \$517,824.00, TO PROVIDE THE PEER POINT PROGRAM TO YOUTH IDENTIFIED AS AT-RISK OF JUVENILE JUSTICE INVOLVEMENT IN THE COMMUNITY, FOR A PERIOD EFFECTIVE RETROACTIVELY AS OF JULY 1, 2025, THROUGH JUNE 30, 2026**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the Probation Department issued a Request for Proposals (RFP) in November 2022 for programs and services to be funded through the Juvenile Probation Camp Funding grant; and

**WHEREAS**, Fresh Lifelines for Youth, Inc. submitted a proposal and entered into an Agreement with the County on June 13, 2023, to provide its Law and Leadership programs to at-risk youth in the community; and

**WHEREAS**, the parties now wish to amend the Agreement by adding funding to allow Fresh Lifelines for Youth, Inc. to allocate two dedicated staff members to provide case management and diversion opportunities to San Mateo County youth through the Peer Point Program; and

**WHEREAS**, this Amendment would add \$250,000.00 to the Agreement for a revised amount not to exceed \$517,824.00, without changing the term; and

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of the Board of Supervisors be and is hereby authorized and directed to execute said amendment for and on behalf of the County of San Mateo, and the Clerk of this Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Chief Probation Officer or his designee is authorized to exercise the contractual options at their discretion and to execute contract amendments that modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term and/or services are within current or revised fiscal provisions.


