**RESOLUTION AUTHORIZING THE DIRECTOR OF HUMAN SERVICES AGENCY OR HER DESIGNEE TO EXECUTE: A) A REVENUE GENERATING AGREEMENT WITH THE STATE OF CALIFORNIA DEPARTMENT OF REHABILITATION TO PROVIDE VOCATIONAL REHABILITATION SERVICES FOR THE MENTAL HEALTH TRANSITION AGE YOUTH AND THE ADULT MENTAL HEALTH POPULATIONS IN THE COUNTY OF SAN MATEO, FOR THE TERM OF JULY 1, 2019 THROUGH JUNE 30, 2022, IN THE AMOUNT OF \$2,672,775; AND B) ADDITIONAL CONTRACT AMENDMENTS THERETO AND ON BEHALF OF THE COUNTY SO LONG AS THE MODIFIED TERM OR SERVICES IS/ARE WITHIN THE CURRENT FISCAL PROVISIONS**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, the San Francisco District of the State of California Department of Rehabilitation (DOR) and the County of San Mateo Vocational Rehabilitation Services (VRS) combine staff and resources to provide vocational rehabilitation services to DOR consumers, who are San Mateo residents, possess a diagnosis of mental illness as designated by the Diagnostic and Statistical Manual of Mental Disorders, Fifth Edition (DSM V), meet DOR and San Mateo County Behavioral Health and Recovery Services (SMCBHRS) criteria for services, and express motivation to seek employment; and

**WHEREAS**, this agreement is a revenue-generating agreement with DOR in the amount of \$2,672,775 which will fund employment services to a minimum of 900 unduplicated County of San Mateo Mental Health consumers with Employment Services, for the term of July 1, 2019 through June 30, 2022; and

**WHEREAS**, this Board has been presented with a form of such revenue generating agreement and said Board has examined and approved same as to both form and content and desires to enter into same.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that the President of this Board of Supervisors be and is hereby authorized and directed to accept a revenue generating agreement with DOR for the term of July 1, 2019 through June 30, 2022 on behalf of the County of San Mateo in an amount of \$2,672.775, and the Clerk of this Board shall attest the President's signature thereto.

**BE IT FURTHER RESOLVED** that the Director of the Human Services Agency (HSA) or the Director's designee is hereby authorized to execute said revenue generating agreement, and any amendments thereto and on behalf of the County so long as the modified term or services is/are within the current fiscal provisions.
