RESOLUTION AUTHORIZING A SECOND AMENDMENT TO THE AGREEMENT WITH LIFEMOVES TO PROVIDE TARGETED STREET-BASED HOMELESS OUTREACH, CASE MANAGEMENT, AND DIVERSION SERVICES AT SAN FRANCISCO INTERNATIONAL AIRPORT (SFO), INCREASING THE AMOUNT BY \$824,418 FOR A REVISED TOTAL AMOUNT NOT TO EXCEED \$7,310,201 AND THE TERM REMAINING UNCHANGED FROM JULY 1, 2025 THROUGH JUNE 30, 2027

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, the County's Human Services Agency (HSA) coordinates homeless outreach program services to engage and stabilize unsheltered homeless individuals and households through consistent outreach to facilitate and/or deliver health and basic needs services and to secure permanent housing; and

WHEREAS, on August 9, 2024, HSA issued a Request for Proposals (RFP) to identify providers of homeless outreach program services and dispatch services throughout San Mateo County; and

WHEREAS, LifeMoves was selected as the Northern San Mateo County, Bayside, and Southern San Mateo County regional provider and the Countywide dispatch services provider, based on their experience, qualifications and overall approach; and

WHEREAS, on December 10, 2024, this Board by Resolution No.080788 entered into an agreement with LifeMoves for the purpose of providing street-based homeless outreach and dispatch services throughout San Mateo County for an amount not to exceed \$6,485,783 for the term of January 1, 2025, through June 30, 2027; and

WHEREAS; on June 23, 2025, the parties amended the agreement to update the budget to allow for the purchase of vehicles to perform homeless outreach activities with no change in term or total obligation; and

WHEREAS, on June 17, 2025, authorized by Resolution No. 081269, HSA entered into an agreement with the City and County of San Francisco to provide street-based homeless outreach, case management, and service linkages to unsheltered individuals at San Francisco International Airport (SFO); and

WHEREAS, the City and County of San Francisco has allocated \$824,418 in funding to HSA for these services; and

WHEREAS; HSA wishes to amend this agreement with LifeMoves to provide targeted street-based homeless outreach, case management, and diversion services at SFO by adding \$824,418 in funds for a revised amount not to exceed \$7,310,201 and the term remaining from July 1, 2025, through June 30, 2027.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to

execute said amendment for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Director of the Human Services Agency or designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in the aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
