**RESOLUTION CERTIFYING AND ADOPTING THE INITIAL STUDY/MITIGATED
NEGATIVE DECLARATION, DATED DECEMBER 2025, TOGETHER WITH THE
RESPONSES TO COMMENTS, AND THE MITIGATION MONITORING AND
REPORTING PROGRAM (MMRP) AS THE FINAL INITIAL STUDY/MITIGATED
NEGATIVE DECLARATION AND MMRP FOR THE ENTRADA WAY
SLIP-OUT REPAIR PROJECT**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Entrada Way is a County maintained road in the unincorporated La Honda area, and it serves as the primary access route for the La Honda community, emergency vehicles, and utility connections, all of which cross the La Honda Creek at the existing culvert; and

WHEREAS, the top of bank of La Honda Creek adjacent to the culvert and surrounding roadway prism have experienced significant damage and erosion as a result of the 2022-2023 winter storms; and

WHEREAS, the Entrada Way Slip-Out Repair Project (Project) will protect the roadway, reduce erosion and sediment delivery, improve stormwater conveyance and local drainage along Entrada Way, enhance water quality by stabilizing the eroded culvert and creek bank, and improve fish passage and habitat in La Honda Creek; and

WHEREAS, an Initial Study/Mitigated Negative Declaration (IS/MND) for the Project has been completed and identified potential adverse effects during construction

that will be reduced to less than implementation of mitigation measures during construction; and

WHEREAS, in compliance with Section 21081.6 of the California Public Resources Code, a Mitigation Monitoring and Reporting Program (MMRP) has been prepared pursuant to the IS/MND; and

WHEREAS, a 30-day public review of the IS/MND was conducted in compliance with the provisions of the California Environmental Quality Act (CEQA); and

WHEREAS, the following entities commented on the Project: California Department of Fish and Wildlife, California Department of Transportation, and one (1) private property owner; and

WHEREAS, responses to all comments received have been prepared and this Board has reviewed and considered said responses; and

WHEREAS, certification of the IS/MND completes the CEQA process for the Project.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

1. The Board of Supervisors has reviewed and considered the IS/MND together with the Responses to Comments on the IS/MND to constitute the Final IS/MND, and on the basis of the record as a whole, confirms that the IS/MND is adequate for its use by this Board, and on the basis of this review and consideration, there is no substantial evidence that the Project will have a significant effect on the

environment if mitigated as set forth in the MMRP and this Board hereby confirms its certification of the IS/MND.

2. The Board of Supervisors hereby adopts the Responses to Comments Mitigated Negative Declaration and the Mitigation Monitoring and Reporting Program attached hereto as Exhibit A-1 and Exhibit B-1, respectively, and incorporated by reference in this Resolution and commits to all mitigation measures identified in the IS/MND and contained in the Responses to Comments Mitigated Negative Declaration and MMRP.
3. The Board of Supervisors of the County of San Mateo hereby certifies this Final IS/MND.
