RESOLUTION AUTHORIZING THE COUNTY EXECUTIVE, OR DESIGNEE, TO EXECUTE AN AGREEMENT WITH THE UNIVERSITY OF CALIFORNIA, DAVIS FOR AN EVALUATION OF THE SAN MATEO COUNTY GUN VIOLENCE PREVENTION PROGRAM FOR THE TERM OF JULY 1, 2023, THROUGH DECEMBER 31, 2024, IN A TOTAL AMOUNT NOT TO EXCEED \$224,220

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, to promote public safety, the County of San Mateo has established the San Mateo County Gun Violence Prevention Program; and

WHEREAS, the San Mateo Gun Violence Prevention Program is a collaborative effort of law enforcement, the San Mateo Superior Court, and the District Attorney's Office to enforce unlawful firearm possession laws more effectively, in the interest of reducing gun violence in the County; and

WHEREAS, the Gun Violence Prevention Program is designed to include development of ongoing evaluation of performance metrics; and

WHEREAS, the University of California, Davis Violence Prevention Research Program is a national leader in research on the nature, causes, consequences, and prevention of violence, especially gun violence; and

WHEREAS, the County wishes to contract with the University of California, Davis Violence Prevention Research Program for and for an evaluation of the San Mateo County Gun Violence Prevention Program to determine, among other things, whether it is producing the desired public safety outcomes; and

WHEREAS, the Board has been presented with a draft of an agreement for an eighteen--month evaluation with a fiscal obligation not to exceed \$224,220 and the

agreement will be negotiated and finalized in a form acceptable to the Contractor and the County Attorney and executed by the County Executive or Designee.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors by adoption of this resolution hereby authorizes the County Executive or Designee to execute an agreement with the University of California, Davis for an evaluation of the San Mateo County Gun Violence Prevention Program, in a form substantially similar to the draft agreement and approved by the County Attorney, and in an amount not to exceed \$224,220.

BE IT FURTHER RESOLVED that the County Executive or Designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
