RESOLUTION AUTHORIZING:

1. THE ACCEPTANCE OF CASH DONATIONS IN THE AMOUNT OF \$249,447 FROM THE SAN MATEO COUNTY PARKS FOUNDATION, \$35,000 FROM THE FRIENDS OF HUDDART AND WUNDERICH PARKS, \$5,000 FROM THE WOODSIDE COMMUNITY FOUNDATION, \$5,000 FROM THE WOODSIDE TRAIL CLUB, AND \$14,194.48 FROM THE MOUNTED PATROL OF SAN MATEO COUNTY; AND 2. THE ACCEPTANCE OF IN-KIND DONATIONS IN THE AMOUNT OF \$130,386 FROM THE SAN MATEO COUNTY PARKS FOUNDATION

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, this Board of Supervisors highly values and appreciates financial contributions to the San Mateo County Parks Department (the "Parks Department"); and

WHEREAS, the San Mateo County Parks Foundation ("Parks Foundation") is providing \$249,447 in cash donations to the Parks Department for the 2024-25 Fiscal Year to help fund projects, programs, and events at various County parks; and

WHEREAS, the \$249,447 in cash donations from the Parks Foundation will be deposited in the Parks Department's Gifts and Donations revenue account and used as follows: \$40,000 for the Nomination of Sam McDonald Park to the National Register of Historic Places; \$31,228 for the Memorial Park Nature Center; \$7,479 for Huddart Park Bridge Repair; \$4,000 for Fitzgerald Marine Reserve Grey Whale Display; \$5,000 for the Memorial Park Centennial Picnic; \$55,000 for Bilingual Community Engagement

Intern; \$15,000 for Bicycle Sunday; \$50,000 for Coyote Point Hazard Tree Fund; \$18,000 for Summer Naturalist Interns at Memorial Park; \$10,000 for Habitat Restoration in San Bruno Mountain State and County Park; \$13,500 for Parks' Memorial Bench Program; and \$240 for Vehicle Entrance Passes for Events; and

WHEREAS, is Fiscal Year 2024-25, the Parks Foundation has provided in-kind donations totaling \$130,386 for various projects, programs, and events; and

WHEREAS, the Parks Department received a cash donation of \$35,000 from the Friends of Huddart and Wunderlich Parks for improvements to the Wunderlich Park ranger residence; and

WHEREAS, the Parks Department received a cash donation of \$14,194.48 from the Mounted Patrol of San Mateo County, \$5,000 from the Woodside Community Foundation, and \$5,000 from the Woodside Trail Club for the Huddart Park Greer Road Bridge Replacement Project.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors by adoption of this Resolution hereby authorizes the acceptance of cash donations in the amount of \$249,447 from the San Mateo County Parks Foundation, \$35,000 from the Friends of Huddart and Wunderlich Parks, \$14,194.48 from the Mounted Patrol of San Mateo County, \$5,000 from the Woodside Community Foundation, and \$5,000 from the Woodside Trail Club for FY 2024-25.
