RESOLUTION AUTHORIZING:

- A) ACCEPTANCE OF HOME SAFE FUNDING FROM THE BUDGET ACT OF 2025 THROUGH CALIFORNIA DEPARTMENT OF SOCIAL SERVICES FOR THE HOME SAFE PROGRAM IN THE AMOUNT OF \$1,023,027 AND
 - B) AN AGREEMENT WITH INSTITUTE ON AGING FOR HOME SAFE PROGRAM SERVICES, FOR THE TERM OF JANUARY 1, 2026 THROUGH AUGUST 31, 2027, IN AN AMOUNT NOT TO EXCEED \$650,000

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California,

WHEREAS, in 2018, AB 1811 established Home Safe, a state funded, locally administered program that aims to prevent or address homelessness among older adults and adults with disabilities who are clients of Adult Protective Services (APS) or in the APS intake process; and

WHEREAS, this Board approved Resolution #078553 on November 16, 2021, accepting Budget Act of 2021 funds for Home Safe from the California Department of Social Services (CDSS) in the amount of \$897,589; and

WHEREAS, this Board approved Resolution #079367 on December 13, 2022, accepting Budget Act of 2022 funds for Home Safe from CDSS in the amount of \$897,589; and

WHEREAS, in October 2022 Aging and Disability Services (ADS) conducted a Request for Proposals process for Home Safe and selected Institute on Aging (IOA) as the Home Safe service provider; and

WHEREAS, the County's initial contract with IOA totaled \$700,000 and extended through June 30, 2024, and a subsequent contract provided an additional \$700,000 through June 30, 2025, and the County further extended the agreement through December 31, 2025, allocating an additional \$175,000 in County General Funds, resulting in a final contract amount of \$875,000; and

WHEREAS, In November 2025, CDSS announced new Home Safe funding through Budget Act 2025 in the amount of \$1,023,027 for San Mateo County; and

WHEREAS, the County, acting through Aging and Disability Services (ADS) wishes to accept San Mateo's allocation of \$1,023,027 in Home Safe funding from the State and enter into an agreement with IOA in the amount of \$650,000 from January 2026 through August 2027.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of this Board of Supervisors be and is hereby authorized and directed to accept the noncompetitive allocation of Budget Act of 2025 funds in the amount of \$1,023,027 and to execute the agreement with IOA in the amount of \$650,000 from January 1, 2026, through August 31, 2027, for and on behalf of the County of San Mateo, and the Clerk of the Board shall attest the President's signature thereto.

BE IT FURTHER RESOLVED that the Chief of San Mateo County Health or the Chief's designee is authorized to execute contract amendments which modify the County's maximum fiscal obligation by no more than \$25,000 (in aggregate), and/or modify the contract term and/or services so long as the modified term or services is/are within the current or revised fiscal provisions.
