**RESOLUTION ESTABLISHING A “NO PARKING” ZONE ON THE EASTERLY SIDE  
OF EL CAMINO REAL COMMENCING A POINT 33 FEET SOUTHERLY OF THE  
INTERSECTION OF COLUMBIA AVENUE AND EXTENDING SOUTHERLY A  
DISTANCE OF 60 FEET, MORE OR LESS IN THE UNINCORPORATED NORTH  
FAIR OAKS AREA**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, California Vehicle Code Section 22506, et seq., and Section 7.30.010 of the San Mateo County Ordinance Code allow this Board of Supervisors to prohibit or restrict the stopping, parking or standing of vehicles by resolution or ordinance with associated signs and markings in their respective jurisdictions on state highways; and

**WHEREAS**, SamTrans seeks to improve operations, visibility and access for passengers at the bus stop on El Camino Real near Columbia Avenue in the unincorporated North Fair Oaks area; and

**WHEREAS**, the Department of Public Works has evaluated the area and determined that restricting parking at the bus stop on the easterly side of El Camino Real near Columbia Avenue will improve passenger visibility and enhance access; and

**WHEREAS**, the Director of Public Works has recommended that a “No Parking” zone be established as noted herein and on Exhibit A attached hereto; and

**WHEREAS**, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** as follows:

1. A "No Parking" zone is declared to exist on the easterly side of El Camino Real (State Route 82) commencing at a point 33 feet southerly of the centerline of Columbia Avenue and extending southerly on El Camino Real a distance of 60 feet, more or less.
2. The Department of Public Works is authorized and directed to post any necessary signs and pavement markings.
