

**FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT
FOR GENERAL SURGERY SERVICES
BETWEEN THE COUNTY OF SAN MATEO AND
SUTTER BAY MEDICAL FOUNDATION**

AMENDMENT TO THE AGREEMENT, entered into this _____ day of May 2020, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Sutter Bay Medical Foundation, a California nonprofit public benefit corporation dba Palo Alto Medical Foundation for Health Care, Research and Education hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an agreement for general surgery services on June 5, 2018, for the term of July 1, 2018 through June 30, 2020, in an amount not to exceed \$2,050,000 ("Agreement");

WHEREAS, the parties now wish to amend the Agreement to extend the term by one year to June 30, 2021, to increase the amount payable thereunder by \$1,025,000 to an amount not to exceed \$3,075,000, and to revise the list of contracted providers included in Exhibit D.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

1. Section 1.5.1 Maximum Amount of the Agreement is amended in its entirety to read as follows:

In full consideration of Contractor's performance of the services described in Exhibit A, the amount that County shall pay for services rendered under this Agreement shall be as specified in Exhibit B, not to exceed THREE MILLION SEVENTY-FIVE THOUSAND DOLLARS (\$3,075,000).

2. Section 3.1 Term of the Agreement is amended in its entirety to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from July 1, 2018, through June 30, 2021. The parties agree that, as of the Effective Date, this Agreement shall replace and supersede any prior or current Agreement between County and Contractor for the same or similar services. Upon execution of this Agreement, the parties shall reconcile any payments made or pending for services

rendered on and after the Effective Date to comply with the terms of this Agreement.

3. Exhibit B, Section IX of the Agreement is amended in its entirety to read as follows:

Unless increased pursuant to Paragraph g of Section VII of Exhibit A, total payment for services performed under this Agreement will not exceed NINE HUNDRED THIRTY FOUR THOUSAND TWO HUNDRED DOLLARS (\$934,200) per year. Over the three year term of this Agreement, the maximum amount payable will not exceed THREE MILLION SEVENTY-FIVE THOUSAND DOLLARS (\$3,075,000).

4. Exhibit B, Section X of the Agreement is amended in its entirety to read as follows:

The term of this Agreement is July 1, 2018 through June 30, 2021, as stated in Section 3.1 of this Agreement.


