**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY
RESOLUTION 081316 TO DELETE TEN POSITIONS, ADD TEN POSITIONS, AND
ADJUST THE SALARY RANGE OF TWO CLASSIFICATIONS; AND ACCEPT THE
UPDATED REPORT OF BIWEEKLY SALARIES BY CLASSIFICATION**

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 073703 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 081316 as follows:

SECTION 1: Section 14 of the Resolution is amended as indicated:

14000 CONTROLLER'S OFFICE

1. Item D060, Financial Services Manager I is decreased by 2 positions for a new total of 0 positions.

2. Item D110, Information Technology Manager is increased by 1 position for a new total of 4 positions.
3. Item D151, Financial Services Manager II is increased by 1 position for a new total of 1 position.

18000 TECHNOLOGY SERVICES DEPARTMENT

1. Item E350, Fiscal Office Specialist is decreased by 1 position for a new total of 0 positions.
2. Item E030S, Accountant Series, is increased by 1 position for a new total of 4 positions.

1. Item T064S, Utility Worker Series is decreased by 1 position for a new total of 0 positions.
