AMENDMENT TO AGREEMENT BETWEEN THE COUNTY OF SAN MATEO AND BAY AREA TREE SPECIALISTS

THIS AMENDMENT TO THE AGREEMENT, entered into this <u>9</u>th day of <u>April</u>, 20<u>24</u>, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and Bay Area Tree Specialists, hereinafter called "Contractor";

WITNESSETH:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for tree removal services to reduce fire fuel on May 23, 2023; and

WHEREAS, the parties wish to amend the Agreement to increase the maximum amount to be expended by \$245,080 for a total amount of \$527,580.

WHEREAS, the parties wish to amend the Agreement to extend the term to December 31, 2024.

NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:

- 1. Section 3 of the agreement is amended to read as follows:
 - In no event shall County's total fiscal obligation under this Agreement exceed \$527,580.
- 2. Section 4 of the Agreement is amended to read as follows:
 - Subject to compliance with all terms and conditions, the term of this Agreement shall be from May 24, 2023 through December 31, 2024.
