Shawn Marshall

For Her Outstanding Leadership In Transforming California's Energy Landscape And Being Named A 2025 Woman Of Influence By The Silicon Valley Business Journal

WHEREAS, SHAWN MARSHALL, Chief Executive Officer (CEO) of Peninsula Clean Energy, has been named a 2025 Woman of Influence by the Silicon Valley Business Journal in recognition of her trailblazing leadership, commitment to public service, and transformative impact on California's clean energy future; and

WHEREAS, SHAWN MARSHALL'S dedication to climate action began during her service as a City Councilmember and Mayor of the City of Mill Valley in Marin County, where she helped found Marin Clean Energy, the first community choice energy (CCE) agency in California; and

WHEREAS, building on that foundation, *SHAWN MARSHALL* went on to help launch many of the state's leading CCE agencies, including Peninsula Clean Energy, Silicon Valley Clean Energy, East Bay Community Energy, and San José Clean Energy, while also founding LEAN Energy US, a nonprofit dedicated to advancing CCE across the country; and

WHEREAS, after joining Peninsula Clean Energy as Chief Operating Officer in 2022, SHAWN MARSHALL was appointed CEO in 2023, and has since led the agency through a period of rapid expansion, including the addition of over 400 megawatts of new renewable energy and battery storage, and major growth in programs supporting zero-emission buildings and clean transportation; and

WHEREAS, under her leadership, Peninsula Clean Energy has more than doubled customer rate savings from \$23 million in 2023 to over \$46 million in 2024 and invested more than \$68 million in local clean energy initiatives; and

WHEREAS, a longtime advocate for gender equity in the energy industry, *SHAWN MARSHALL* has helped create pathways for female leadership across the industry, helping shape a generation of female leaders, and contributing to a majority of California's 24 operational CCE's now being led by women; and

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of San Mateo, State of California, hereby honors and commends **SHAWN MARSHALL** for her outstanding leadership, dedication for a cleaner, more equitable future for all, and her well-deserved recognition as a 2025 Woman of Influence.
