**RESOLUTION: A) CONSOLIDATING THE PRESIDENTIAL GENERAL ELECTION, TO BE HELD ON TUESDAY, NOVEMBER 3, 2020, WITH ELECTIONS CALLED BY THE SAN MATEO COUNTY BOARD OF EDUCATION, BRISBANE SCHOOL DISTRICT, CABRILLO UNIFIED SCHOOL DISTRICT, JEFFERSON ELEMENTARY SCHOOL DISTRICT, JEFFERSON UNION HIGH SCHOOL DISTRICT, LA HONDA-PESCADERO UNIFIED SCHOOL DISTRICT, LAS LOMITAS ELEMENTARY SCHOOL DISTRICT, MENLO PARK CITY SCHOOL DISTRICT, PACIFICA SCHOOL DISTRICT, RAVENSWOOD CITY SCHOOL DISTRICT, SAN BRUNO PARK SCHOOL DISTRICT, SAN MATEO COUNTY COMMUNITY COLLEGE DISTRICT, SAN MATEO-FOSTER CITY SCHOOL DISTRICT, SAN MATEO UNION HIGH SCHOOL DISTRICT, SEQUOIA UNION HIGH SCHOOL DISTRICT, TOWN OF ATHERTON, CITY OF BELMONT, CITY OF BRISBANE, TOWN OF COLMA, CITY OF DALY CITY, CITY OF EAST PALO ALTO, CITY OF FOSTER CITY, CITY OF HALF MOON BAY, TOWN OF HILLSBOROUGH, CITY OF MENLO PARK, CITY OF MILLBRAE, CITY OF PACIFICA, TOWN OF PORTOLA VALLEY, CITY OF REDWOOD CITY, CITY OF SAN BRUNO, CITY OF SAN CARLOS, CITY OF SAN MATEO, CITY OF SOUTH SAN FRANCISCO, TOWN OF WOODSIDE, HIGHLANDS RECREATION DISTRICT, LADERA RECREATION DISTRICT, MENLO PARK FIRE PROTECTION DISTRICT, PENINSULA CORRIDOR JOINT POWERS BOARD, SAN MATEO COUNTY HARBOR DISTRICT, AND MIDCOAST COMMUNITY COUNCIL; AND B) AUTHORIZING THE COUNTY'S CHIEF ELECTIONS OFFICER TO RENDER SPECIFIED ELECTION SERVICES IN CONJUNCTION THEREWITH**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, Sections 10400 through 10418 of the Elections Code authorize the consolidation of elections that are called to be held on the same day in or within the same territory upon the order of the governing body or bodies calling the elections, the consolidation may be ordered by the County Board of Supervisors upon request, and

the consolidated election shall be held in all respects as if it were one election, with the returns being canvassed by the County's Chief Elections Officer; and

**WHEREAS**, absent other arrangements or applicable law, the costs of any school district election shall be borne by the school district holding the election pursuant to Section 5421 of the Education Code, and any city or district shall reimburse the County in full for the services performed by the County's Chief Elections Officer in accordance with Division 10 of the Elections Code; and

**WHEREAS**, pursuant to state law, the San Mateo County Board of Education, Brisbane School District, Cabrillo Unified School District, Jefferson Elementary School District, La Honda-Pescadero Unified School District, Las Lomas Elementary School District, Menlo Park City School District, Pacifica School District, Ravenswood City School District, San Bruno Park School District, San Mateo County Community College District, San Mateo Union High School District, and Sequoia Union High School District are required to hold regularly-scheduled governing board elections, and the named jurisdictions have notified the County's Chief Elections Officer of the number of seats to be elected and the relevant policies for breaking a tie vote, and the named jurisdictions are requesting an election as more candidates have filed to run for office in the named jurisdictions than there are seats available; and

**WHEREAS**, pursuant to state law, the Highlands Recreation District, Ladera Recreation District, Menlo Park Fire Protection District, San Mateo County Harbor District, and Midcoast Community Council are required to hold regularly scheduled governing board elections, and the named jurisdictions have notified the County's Chief

Elections Officer of the number of seats to be elected and the boundaries of the district, and the named jurisdictions are requesting an election as more candidates have filed to run for office in the named jurisdictions than there are seats available; and

**WHEREAS**, pursuant to state law, the governing board of the Jefferson Union High School District adopted Resolution No. 2019-2020/6, giving notice of holding a special election to be held on November 3, 2020, for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

**WHEREAS**, pursuant to state law, the governing board of the San Mateo-Foster City School District adopted Resolution No. 01/20-21, giving notice of holding a special election to be held on November 3, 2020, for the purpose of submitting a bond measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

**WHEREAS**, pursuant to state law, the governing board of the Peninsula Corridor Joint Powers Board adopted Resolution No. 2020-41, giving notice of holding a special election to be held on November 3, 2020, for the purpose of submitting a sales tax measure to District voters, and requesting the County's Chief Elections Officer to render specified election services to the District therefor; and

**WHEREAS**, pursuant to state law, the City Council of the Town of Atherton adopted Resolution Nos. 20-16 and 20-17, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing two city council members for a term of four years each, and requesting the

County's Chief Elections Officer to render specified election services to the Town therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Belmont adopted Resolution Nos. 2020-059 and 2020-060, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing two city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Brisbane adopted Resolution No. 2020-48, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing three city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the Town of Colma adopted Resolution Nos. 2020-25 and 2020-26, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing three city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the Town therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Daly City adopted Resolution Nos. 20-78 and 20-131 giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose

of electing two city council members, a city clerk, and a city treasurer for a term of four years each, submitting to Daly City voters a sales tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of East Palo Alto adopted Resolution Nos. 76-2020 and 99-2020, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing three city council members for a term of four years each, submitting to East Palo Alto voters a transient occupancy tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Foster City adopted Resolution No. 2020-59, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing three city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Half Moon Bay adopted Resolution Nos. C-2020-39 and C-2020-78, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing two city council members for a term of four years each, submitting to Half Moon Bay voters a transient occupancy tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the Town of Hillsborough adopted Resolution Nos. 20-33 and 20-34, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing three city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the Town therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Menlo Park adopted Resolution No. 6562, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing two city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Millbrae adopted Resolution Nos. 20-39, 20-40, and 20-41, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing three city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Pacifica adopted Resolution No. 39-2020, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing two city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the Town Council of the Town of Portola Valley adopted Resolution No. 2830-2020, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing two town council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the Town therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of Redwood City adopted Resolution Nos. 15847, 15848, and 15849, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing four city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of San Bruno adopted Resolution Nos. 2020-44, 2020-60, and 2020-61, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing two city council members, and a mayor for a term of four years each, submitting to San Bruno voters a transient occupancy tax measure and a cannabis business tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of San Carlos adopted Resolution No. 2020-029, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing

two city council members, and a city treasurer for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of San Mateo adopted Resolution Nos. 46 (2020), 47 (2020), 78 (2020), and 81 (2020), giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing two city council members for a term of four years each, submitting to San Mateo voters two General Plan amendment measures, and a transient occupancy tax measure, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the City Council of the City of South San Francisco adopted Resolution No. 74-2020, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing two city council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the City therefor; and

**WHEREAS**, pursuant to state law, the Town Council of the Town of Woodside adopted Resolution No. 2020-7356, giving notice of holding a regularly scheduled general municipal election to be held on November 3, 2020, for the purpose of electing four town council members for a term of four years each, and requesting the County's Chief Elections Officer to render specified election services to the Town therefor; and

**WHEREAS**, each of the aforementioned districts and municipalities has requested their respective elections to be consolidated with the November 3, 2020, Presidential General Election; and

**WHEREAS**, the County's Chief Elections Officer is agreeable to providing specified election services as duly requested and enumerated above in conjunction with the Presidential General Election to be held on Tuesday, November 3, 2020; and

**WHEREAS**, in consideration of the services and supplies to be provided by the Chief Elections Officer in conducting said election, the San Mateo County Board of Education, Brisbane School District, Cabrillo Unified School District, Jefferson Elementary School District, Jefferson Union High School District, La Honda-Pescadero Unified School District, Las Lomas Elementary School District, Menlo Park City School District, Pacifica School District, Ravenswood City School District, San Bruno Park School District, San Mateo County Community College District, San Mateo-Foster City School District, San Mateo Union High School District and Sequoia Union High School District, Town of Atherton, City of Belmont, City of Brisbane, Town of Colma, City of Daly City, City of East Palo Alto, City of Foster City, City of Half Moon Bay, Town of Hillsborough, City of Menlo Park, City of Millbrae, City of Pacifica, Town of Portola Valley, City of Redwood City, City of San Bruno, City of San Carlos, City of San Mateo, City of South San Francisco, Town of Woodside, Highlands Recreation District, Ladera Recreation District, Menlo Park Fire Protection District, Peninsula Corridor Joint Powers Board, San Mateo County Harbor District, and Midcoast Community Council will, as required by law, enter into separate agreements with the County's Chief Elections

Officer to outline the services to be rendered and to reimburse the County for the costs of said services and supplies.

**NOW THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** that (A) the November 3, 2020 Presidential General Election is hereby consolidated with the above-named local elections duly called by their respective governing bodies; and (B) the County's Chief Elections Officer is authorized to render specified election services in conjunction therewith.
