**RESOLUTION: 1. ADOPTING THE GARBAGE AND RECYCLABLES COLLECTION SERVICE CHARGES REPORT FOR COUNTY SERVICE AREA NO. 8 (NORTH FAIR OAKS) FOR FISCAL YEAR 2025-26; AND 2. APPROVING THE SUBMITTAL OF THE GARBAGE AND RECYCLABLES COLLECTION SERVICE CHARGES REPORT FOR NORTH FAIR OAKS FOR FISCAL YEAR 2025-26 WITH THE COUNTY CONTROLLER BY THE DIRECTOR OF THE SUSTAINABILITY DEPARTMENT; AND 3. AUTHORIZING THE DIRECTOR OF THE SUSTAINABILITY DEPARTMENT TO REFUND ANY OVERCHARGES RESULTING FROM DATA, DATA ENTRY, OR COMPUTATION ERRORS; AND 4. AUTHORIZING THE CLERK TO FILE THE REPORT WITH THE COUNTY CONTROLLER BY AUGUST 12, 2025**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, acting as the Governing Board of San Mateo County Service Area No. 8 (North Fair Oaks), that

**WHEREAS**, the County pays Recology for residential dwelling garbage services in North Fair Oaks by collecting fees from property owners, based on the required minimum residential garbage service levels for the property, as outlined in County Ordinance Code 4.04.220; and

**WHEREAS**, on January 14, 2025, the Board adopted Resolution No. 080851, setting the garbage and collection rates for North Fair Oaks, which take effect July 1, 2025, for those properties that pay for garbage and collection services via the County tax roll; and

**WHEREAS**, San Mateo County Ordinance Code Section 4.04.200 through 4.04.330 require that garbage and recyclables collection service charges for parcels that contain residential dwelling units in North Fair Oaks be collected through the

property tax roll; the amount owed by each parcel for garbage and recyclables collection services is listed in the Collection Service Charges Report filed with the Clerk of the Board; and

**WHEREAS**, the Director of the Sustainability Department of the County of San Mateo has prepared the report described in San Mateo County Ordinance Code Sections 4.04.200 through 4.04.330; and

**WHEREAS**, the date and time of the public hearing was advertised in both English and Spanish in The Redwood City Tribune newspaper on July 16 and July 23, in advance of the public hearing; and

**WHEREAS**, during a public hearing, held in-person, on August 12, 2025, at 9:15 am, members of the public were able to participate in the meeting in person in Board Chambers or via Zoom platform, or submit a written statement to the Clerk of the Board, as required by Section 4.04.270 of the San Mateo County Ordinance Code; and

**WHEREAS**, this Board heard and considered all objections or protests to said report at said public hearing and determined that the Garbage and Recyclables Collection Service Charges Report for North Fair Oaks for FY 2025-26 should be confirmed and adopted.

**NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED** as follows:

1. This Board does hereby confirm and adopt said report and imposes the service charges set forth therein to be, and the same are hereby, established and set

for FY 2025-26.

2. The Director of the Sustainability Department is hereby directed to certify to the Clerk of this Board that the service charges were calculated in accordance with the garbage and recyclables collection rates adopted by this Board.
3. The Director of Sustainability Department is directed to file with the Controller an electronic copy of said report and a statement endorsed thereon that the service charges as set forth in said electronic copy are the charges as adopted by this Board based on the certification of the Director of the Sustainability Department.
4. The Director of the Sustainability Department is authorized to refund, as appropriate, any overcharge contained in said report to the owner of the parcel so overcharged when the overcharge resulted from data, data entry, computation errors as determined by the Director of the Sustainability Department.
5. Authorizing the Clerk to file the Report with the County Controller by August 12, 2025.


