5.1 Parks Department Report – SMC Parks Director Nicholas Calderon Highlights include:

- Flood Park pump track, followed by basketball court, is most popular amenity. Starting demolition of playground and planning for additional restroom.
- Closed community surveying for rebuild of Coyote Point Magic Mountain playground great data from community.
- Successful Summerfest at Coyote Point Park with 3000 people.
- Upcoming Fallfest on September 20 at Flood Park.
- Pop-up restaurant Maverick Jack's at Coyote Point Park, weekends in August, September, and October.
- Budget was approved.
- San Bruno Mountain Day Use Area is underway and going well.

- 5.2 Parks Foundation Director's Report SMC Parks Foundation Director Michele Beasley
 - Purchased 136 annual park passes to send to all libraries in the county 4 per library.
 - Funded 5 groups to go camping at Memorial Park.
 - Coyote Point Park promenade restroom art mural created by Compass Point Membership and funded by Foundation. Ribbon cutting September 6 at 9:30am.
 - Invited commissioners to table alongside the foundation in any parks in their district.

- 6.1 Viva Verde Presentation, recipient of 2024 Fish & Game Propagation Fund grant Arturo Cervantes
 - Vida Verde Nature Education, located in San Gregorio, provides free overnight
 environmental learning experiences to students in Title I schools. Funds from grant were
 used to purchase feed for farm animals (students milk goats and make cheese), transport
 students to Sam McDonald Park and local beaches, and fund groceries for the students.
- 6.2 Parks Department Presentation on Wildfire Mitigation Asst. Parks Director Hannah Ormshaw

This presentation focuses on the 2025 updated wildfire mitigation program, which will be presented to the Board of Supervisors on September 9.

- Wildfire mitigation benefits include managing fire fuels, improving forest health, and improving access for a safe and effective wildfire response.
- Last updated in 2021, the program is being updated due to new spatial data resources available and updated CAL FIRE fire hazard severity zones.
- Project assessments include vegetation type and density, slope and terrain, access, wildlife habitat, and sensitive resources and permitting considerations.

Projects include:

- Shaded fuel breaks in forested areas include thinning of understory, examples at Edgewood Park and Quarry Park
- Non-shaded fuel breaks (shrub vegetation or flammable weed species), example at San Bruno Mountain
- Forest health treatments (via CAL FIRE grant) in parks that have been affected by sudden oak death, examples at Huddart Park and Wunderlich Park
- Ingress and Egress fuel breaks focus on fire roads and access for fire engines
- Forest density reduction includes thinning of sparse stands to allow trees to grow bigger over time
- Fire-related infrastructure improvements, such as bridges and fire roads
- Program benefits projects eligible for grant funding. \$7.6M awarded to date.
