RESOLUTION: A) RESCINDING IN PART "TWO HOUR TIME LIMITED PARKING" ZONES ON A STREET THAT WERE PREVIOUSLY APPROVED BY RESOLUTION NO 067697 ON DECEMBER 6, 2005; AND B) ESTABLISHING "TWO HOUR TIME LIMITED PARKING" ZONES ALONG A STREET BETWEEN REINER STREET AND EL CAMINO REAL IN THE UNINCORPORATED COLMA AREA DURING SPECIFIED HOURS AND DAYS

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, California Vehicle Code Section 22507 et seq. and Section 7.24.010 et seq. of the San Mateo County Ordinance Code allow the Board of Supervisors to prohibit or restrict the stopping, parking or standing of vehicles by resolution or ordinance with associated signs and markings; and

WHEREAS, the Broadmoor Police Department seeks to revise parking restrictions within the County right-of-way on A Street between Reiner Street and El Camino Real (State Highway 82) in the unincorporated Colma Area; and

WHEREAS, this Board authorized previous parking restrictions for "Time Limited Parking" zones along A Street between Reiner Street and El Camino Real, which must be rescinded to facilitate establishing revised parking restrictions in this area; and

WHEREAS, the Director of Public Works has recommended that "Time Limited Parking" zones be established as noted herein and on Exhibit A attached hereto; and

WHEREAS, this Board has reviewed and concurs with the recommendation of the Director of Public Works.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that:

- 1. The "Two Hour Time Limited Parking" zones established per Resolution No. 067697, on December 6, 2005 for A Street at the following locations shall be rescinded:
 - A.) "On the southerly side of "A" STREET commencing at a point 125 feet westerly of the intersection of EL CAMINO REAL, State Highway 82, and extending westerly a distance of 20 feet, more or less."
 - B.) "On the southerly side of "A" STREET commencing at a point 145 feet westerly of the intersection of EL CAMINO REAL, State Highway 82, and extending westerly a distance of 380 feet, more or less, between the hours of 7:00 a.m. and 6:00 p.m., Monday through Friday, holidays excepted."
 - C.) "On the northerly side of "A" STREET commencing at a point 95 feet westerly of the intersection of EL CAMINO REAL, State Highway 82, and extending westerly a distance of 405 feet, more or less, between the hours of 7:00 a.m. and 6:00 p.m., Monday through Friday, holidays excepted."
- 2. "Two Hour Time Limited Parking" zones to be established at the following locations:
 - A.) On the northerly side of A Street commencing ninety-five feet (95.0') west of the center line of El Camino Real, extending westerly a distance of 405 feet, more or less, between the hours of 8:30 a.m. and 5:30 p.m., Monday through Friday, holidays excepted.

B.) On the southerly side of A Street commencing one-hundred twenty-five feet (125.0') west of the center line of El Camino Real, extending westerly a distance of 400 feet, more or less between the hours of 8:30 a.m. and 5:30 p.m., Monday through Friday, holidays excepted.
