**RESOLUTION AUTHORIZING AN AMENDMENT TO MASTER SALARY  
RESOLUTION 076798 TO DELETE FOUR POSITIONS, ADD FOUR POSITIONS, SET  
THE SALARY OF TWO CLASSIFICATIONS, AND CONVERT THREE  
UNCLASSIFIED POSITIONS TO CLASSIFIED VIA MEASURE D.**

**RESOLVED**, by the Board of Supervisors of the County of San Mateo, State of California, that

**WHEREAS**, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

**WHEREAS**, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

**WHEREAS**, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

**NOW THEREFORE, IT IS HEREBY ORDERED** that the Board of Supervisors authorizes an amendment to Master Salary Resolution 076798 as follows:

**SECTION 1:** Part 14 of the Resolution is amended as indicated:

**ORGANIZATION 38000 PLANNING AND BUILDING**

1. Item E337, Office Specialist is decreased by 1 position for a new total of 3 positions.

2. Item E002, Administrative Secretary II is increased by 1 position for a new total of 2 positions.

#### ORGANIZATION 47300 FACILITIES SERVICES

1. Salary for Item N109, Supervising Capital Project Manager is set at \$57.76 to \$72.22 per hour.

#### ORGANIZATION 61000 BEHAVIORAL HEALTH AND RECOVERY SERVICES

1. Item B112S, Mental Health Case Worker - Unclassified Series is decreased by 3 positions for a new total of 5 positions.
2. Item G040S, Mental Health Case Worker Series is increased by 2 positions for a new total of 146 positions.
3. Item G081, Mental Health Program Specialist is increased by 1 position for a new total of 20 positions.
4. Salary for Item G242, Lead Behavioral Health and Recovery Specialist is set at \$41.56 to \$51.93 per hour.

#### ORGANIZATION 66000 SAN MATEO MEDICAL CENTER

1. Item B157, Staff Physician – Unclassified is decreased by 1 position for a new total of 0 positions.
2. Item D182S, Management Analyst Series is increased by 1 position for a new total of 12 positions.

#### ORGANIZATION 70000 HUMAN SERVICES AGENCY

1. Item G216, Veterans Services Officer is decreased by 1 position for a new total of 0 positions.
2. Item D091, Human Services Manager II is increased by 1 position for a new total of 13 positions.
