 - 2. AUTHORIZING AND DIRECTING SUPERVISOR JACKIE SPEIER,
 MEMBER OF THIS BOARD OF SUPERVISORS AND CO-CHAIR OF THE
 SAN MATEO COUNTY CHILD CARE PARTNERSHIP COUNCIL, TO
 EXECUTE AND SUBMIT THE LOCAL PLANNING COUNCIL COUNTY
 PRIORITIES REPORT FORM FOR AND ON BEHALF OF THE COUNTY OF
 SAN MATEO, WHICH CERTIFIES TO THE STATE THAT THE FY 2024-25
 COUNTY SUBSIDY PRIORITIES HAVE BEEN PREPARED AND REVIEWED
 IN ACCORDANCE WITH SECTION 10486(b) OF THE CALIFORNIA
 WELFARE AND INSTITUTIONS CODE

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, Local Child Care Planning Councils (LPCs) were established by the State Legislature in 1991 in every county in California, and San Mateo County Child Care Partnership Council ("Council") is the LPC in San Mateo: and;

WHEREAS, the Council is a publicly funded and appointed body, which is mandated to: identify priorities for the local distribution of state funding for early care and education services for low-income children and families; conduct an early care and education needs assessment every five years; create a county-wide child care strategic plan; develop policies, strategies and resources to promote the goals of the child care strategic plan, and advise San Mateo County on the potential local impact of state and national policies and legislation; and;

WHEREAS, California Welfare & Institutions Code Section 10486(b) requires the LPCs to review local State and Federal data and provide the California Department of Social Services ("Department") with an updated listing of their local child care and development funding priorities by May 30 every year. These priorities are then used by the Department to determine funding decisions; and

WHEREAS, the priority designations are first reviewed and approved by the members of the LPC for each county, which is made up of parent consumers of child care, child care and preschool providers, public agency representatives and community agency representatives, who have been appointed by the County Board of Supervisors and the County Superintendent of Schools, and the priorities are then reviewed and approved by the County Board of Supervisors at a public hearing as prescribed in California Welfare and Institutions Code Section 10486(b); and

WHEREAS, in June 2015, the Department revised the procedures for LPCs to use to determine county subsidy zip code priorities, and the Council gathered data according to the new procedures; and

WHEREAS, at its March 17, 2025 meeting, the Council reviewed the data and adopted new subsidy zip code priorities to recommend to the Board of Supervisors for approval; and

WHEREAS, a public hearing was held by the Board on May 20, 2025 to receive comments; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance, County Subsidy Priorities identifying the need for

California Department of Education State Preschool, Full-Day and Part-Day, whereby the following zip codes in San Mateo County are "underserved" in the ratio of publicly subsidized preschool programs to the need for these services:

Priority 1: 94015, 94061, 94063

Priority 2: 94014, 94030, 94044, 94303

Priority 3: 94002, 94005, 94010, 94019, 94020, 94021, 94025, 94027, 94028, 94037, 94038, 94060, 94062, 94065, 94066, 94070, 94074, 94080,

94401, 94402, 94403, 94404; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance, county zip code priorities identifying the need for California Department of Social Services funded Full-Day Child Care and Development Services for Infants and Toddlers, whereby the following zip codes in San Mateo County are "underserved" in the ratio of publicly subsidized child care to the need for these services:

Priority 1: 94002, 94010, 94014, 94015, 94019, 94025, 94030, 94044, 94061, 94063, 94066, 94080, 94303, 94401, 94402, 94403, 94404

Priority 2: 94005, 94062, 94070

Priority 3: 94020, 94021, 94027, 94028, 94037, 94038, 94060, 94065,

94074; and

WHEREAS, there has been presented to this Board of Supervisors for its consideration and acceptance, county zip code priorities identifying the need for California Department of Social Services funded Part-Day Child Care and Development Services for School Age Children, whereby the following zip codes in San Mateo County are "underserved" in the ratio of publicly subsidized child care to the need for these services:

94044, 94063, 94065, 94066, 94070, 94080, 94303,

94401

Priority 2: 94402, 94403, 94404

Priority 3: 94020, 94021, 94025, 94027, 94028, 94037, 94038, 94060,

94062, 94074; and

WHEREAS, this Board has been presented with a Local Planning Council

County Priorities Report Form, and said Board has examined and approved same as to

both form and content and desires to authorize same.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the Board of Supervisors hereby approves the FY 2024-25 County Subsidy Priorities presented by the San Mateo County Child Care Partnership Council for the distribution of future California Department of Education and California Department of Social Services funding for state preschool, infant-toddler, and school-age child care and development services; and

IT IS FURTHER RESOLVED THAT Supervisor Jackie Speier, member of this Board of Supervisors and Co-Chair of the San Mateo County Child Care Partnership Council, is hereby authorized and directed to execute and submit the Local Planning Council County Priorities Report Form for and on behalf of the County of San Mateo, which certifies to the State that the FY 2024-25 County Subsidy Priorities have been prepared and reviewed in accordance with the requirements of Section 10486(b) of the California Welfare and Institutions Code, and the Clerk of this Board shall attest to the Supervisor's signature thereto.
