RESOLUTION AUTHORIZING AN AMENDMENT TO THE MASTER SALARY RESOLUTION 078309 TO DELETE SIX POSITIONS, ADD SEVEN POSITIONS, CONVERT ONE POSITION TO UNCLASSIFIED, AND CONVERT ONE POSITION TO CLASSIFIED VIA MEASURE D; AND ACCEPT THE UPDATED REPORT OF BIWEEKLY SALARIES BY CLASSIFICATION

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, section 206a(4) of the San Mateo County Charter authorizes the Board of Supervisors to establish the number of all appointed officers and employees; and

WHEREAS, sections 206a(5) and 508 of the San Mateo County Charter authorize the Board of Supervisors to establish by ordinance or resolution the compensation and benefits of County officers and employees; and

WHEREAS, San Mateo County Ordinance No. 07303 ordered that henceforth the number of County appointed officers and employees and their compensation and benefits shall be established by resolution of the Board of Supervisors; and

NOW THEREFORE, IT IS HEREBY ORDERED that the Board of Supervisors authorizes an amendment to Master Salary Resolution 078309 as follows:

SECTION 1: Part 14 of the Resolution is amended as indicated:

ORGANIZATION 17000 HUMAN RESOURCES DEPARTMENT

1. Item D060, Financial Services Manager I is decreased by 1 position for a new total of 0 positions.
2. Item D045, Administrative Services Manager I is increased by 1 position for a new total of 1 position.

ORGANIZATION 30000 SHERIFF'S OFFICE

1. Item B010, Crime Analyst-Unclassified is decreased by 1 position for a new total of 16 positions.
2. Item B182S, Community Program Specialist-Unclassified Series is increased by 1 position for a new total of 1 position.
3. Item E406S, Storekeeper Series is decreased by 1 position for a new total of 3 positions.
4. Item E030S, Accountant Series is increased by 1 position for a new total of 1 position.
5. Item E091, Administrative Assistant II is increased by 1 position for a new total of 5 positions.

ORGANIZATION 55500 PUBLIC HEALTH POLICY AND PLANNING
