RESOLUTION AUTHORIZING THE INSTALLATION OF TWO STREETLIGHTS ON DEVONSHIRE AVENUE IN THE MENLO PARK HIGHWAY LIGHTING DISTRICT

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, acting as the governing board of the Menlo Park Highway Lighting District (District), that

WHEREAS, there has been filed with the District a written request signed by two members of the Board of Supervisors, requesting the installation of a new streetlight on Devonshire Avenue in the vicinity of 180 Buckingham Avenue in the District; and

WHEREAS, District staff has evaluated the existing streetlights and facilities in the vicinity and recommends the installation of two additional streetlights in the vicinity of 180 Buckingham Avenue on Devonshire Avenue; and

WHEREAS, Sections 19160 et seq. of the California Streets and Highways

Code provide that the governing board of a lighting district may make the expense of
the installation of additional lights a charge upon the district if the board determines that
it will be just and equitable and in the public interest for the additional cost to be paid by
the district as a whole; and

WHEREAS, the Director of Public Works has reported that the District has sufficient funds to finance the cost of said lights requested to be installed on Devonshire Avenue within the limits of said District; and

WHEREAS, this Board finds that the cost of the additional lights is just and equitable and in the public interest.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED as follows:

- This Board finds that it is just and equitable and in the public interest for the additional cost of installing and maintaining two additional streetlights on Devonshire Avenue in the unincorporated County area of North Fair Oaks and within the Menlo Park Highway Lighting District's boundary, to be paid by the Menlo Park Highway Lighting District as a whole.
- 2. The installation of two additional streetlights will provide the desired outcome of enhancing illumination of the area, as requested by two members of the Board of Supervisors, and as recommended by the Department, is hereby ordered pursuant to Section 19161 of the California Streets and Highways Code.
- The cost of installation and maintenance of said streetlights shall be a charge upon the Menlo Park Highway Lighting District.
- 4. The Director of Public Works is authorized to notify Pacific Gas and Electric Company that all billings for the additional streetlights within the Menlo Park Highway Lighting District shall be forwarded to the Department of Public Works for payment.
