

**AMENDMENT TO AGREEMENT  
BETWEEN THE COUNTY OF SAN MATEO AND  
REPUBLIC SERVICES OF SAN MATEO COUNTY**

THIS AMENDMENT TO THE AGREEMENT, entered into this 1st day of May, 2024, by and between the COUNTY OF SAN MATEO, hereinafter called "County," and BFI WASTE SYSTEMS OF NORTH AMERICA, LLC DBA REPUBLIC SERVICES OF SAN MATEO COUNTY hereinafter called "Contractor";

W I T N E S S E T H:

WHEREAS, pursuant to Government Code, Section 31000, County may contract with independent contractors for the furnishing of such services to or for County or any Department thereof;

WHEREAS, the parties entered into an Agreement for operating the Pescadero Transfer Station dated August 18, 2018, No. 076251, between the County of San Mateo and BFI Waste Systems of North America, LLC, dba Republic Services of San Mateo County; and

WHEREAS, the parties wish to amend the Agreement to extend the contract for an additional mutually agreed upon term not to exceed six (6) months.

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS FOLLOWS:**

1. Section 4. Term of the agreement is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement shall be from August 18th, 2018, through August 1, 2023. Amendment 1 extended the term not to exceed one-year (12 months) ending on August 30, 2024. Amendment 2 extends the term for a period not to exceed six (6) months ending on February 28, 2025

2. Exhibit A, Section JJ. Duration of Contract/Terms, Item 1a., of the agreement is amended to read as follows:

1. Duration of Contract

- a. The term of this original agreement is for sixty (60) months beginning on August 18, 2018 and ending on August 01, 2023. Amendment 1 extended this contract for a period not to exceed one-year (12 months) ending on

August 30, 2024. Amendment 2 extends this contract for a period not to exceed six (6) months ending on February 28, 2025. Subject to compliance with all terms and conditions, the term of this Agreement term shall be from August 18th, 2018, through February 28, 2025.

- 4. All other terms and conditions of the agreement dated August 18, 2018, between the County and Contractor shall remain in full force and effect.**
