RESOLUTION AUTHORIZING AN AGREEMENT WITH THE CADRE RESEARCH LABS ILLINOIS LLC TO PROVIDE ADVANCED THREE-DIMENSIONAL IMAGING AND ANALYSIS SOLUTIONS FOR FORENSIC FIREARM AND TOOLMARK EXAMINATION AND THREE YEARS OF MAINTENANCE AND SUPPORT BEGINNING WITH INSTALLATION, WHICH IS ESTIMATED TO BE ON AUGUST 11, 2026, FOR AN AGREEMENT TERM OF MAY 5, 2026 THROUGH AUGUST 10, 2029, IN AN AMOUNT NOT TO EXCEED \$302,105.31

RESOLVED, by the Board of Supervisors of the County of San Mateo, State of California, that

WHEREAS, in the course of law enforcement activities, it is necessary to gather forensic evidence to establish objective facts in legal proceedings, primarily to identify perpetrators, link suspects to crime scenes, and exonerate the innocent; and

WHEREAS, firearms evidence is used to identify, link, and analyze weapons, ammunition, and toolmarks found at crime scenes to assist law enforcement in solving crimes, determining firearm functionality, establishing connections between suspects and weapons, and linking shooting events together; and

WHEREAS, the Sheriff's Office has executed an agreement with the State of California Board of State and Community Corrections (BSCC) for distribution of the FY 2025 Edward Byrne Memorial Justice Assistance Grant (JAG) program funds to enable the purchase of a 3D imaging platform for firearms evidence; and

WHEREAS, the Board of Supervisors authorized the execution of said agreement with the State of California Board of State and Community Corrections under Resolution Number 081542; and

WHEREAS, in January 2026, the County issued a request for proposals for a 3D imaging and analysis system for firearm and toolmark examination; and

WHEREAS, the Sheriff's Office received one proposal from a qualified and responsible vendor; and

WHEREAS, both parties now wish to enter into an agreement to provide advanced three-dimensional imaging and analysis solutions for forensic firearm and toolmark examination, including High Capacity Desktop and Versa Portable 3D scanning systems, analysis software, and databases that enable virtual comparison microscopy analysis of bullets, cartridge cases, and toolmarks, and three years of support and maintenance which will begin at installation. Installation is estimated to occur fourteen weeks after order placement which will be on or near August 11, 2026. The agreement term will be for three years and fourteen weeks, from May 5, 2026 through August 10, 2029, in an amount not to exceed \$302,105.31; and

WHEREAS, the Sheriff's Office recommends the Board approve an agreement with Cadre Research Labs Illinois LLC, for the provision of a three-dimensional imaging and analysis solution for forensic firearm and toolmark examination, and for the provision of support and maintenance for a three-year period; and

WHEREAS, this Board has been presented with a form of such agreement and has examined and approved it as to both form and content and desires to enter into the agreement.

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED that the President of the Board of Supervisors, on behalf of the County of San Mateo, authorizes execution of an agreement with Cadre Research Labs Illinois LLC for the High Capacity

Desktop and Versa Portable 3D scanning systems, analysis software, and databases, and for support and maintenance for a three-year period, in an amount not to exceed \$302,105.31.

BE IT FURTHER RESOLVED that the Sheriff or Sheriff's designee is hereby authorized and directed to execute all necessary documents, contract amendments, and minor modifications to this agreement not to exceed an aggregate of \$25,000, and/or modify the contract term and/or services so long as the modified term or services are within the current or revised fiscal provisions.
