WHEREAS, this Board has today opened and examined all of the written proposals timely submitted by qualified proposers and has called for oral bids as set forth in the Board's April 22, 2014 resolution of intention regarding the Property; and

WHEREAS, there has been presented to this Board of Supervisors for its

WHEREAS, this Board, as the lead agency, is required to comply with the California Environmental Quality Act (CEQA) and pursuant to section 15312 of the CEQA guidelines, has determined that the Property is surplus, and categorically exempt under the California Environmental Quality Act (CEQA); and
