

**Second Amendment to Agreement
Between the County of San Mateo and Marta Banh, OD for Optometry Services**

THIS AMENDMENT TO THE AGREEMENT, entered into **this 26 day**
of August 2025, by and between the COUNTY OF SAN MATEO, hereinafter
called "County," and **Marta Banh, OD**, hereinafter called "Contractor";

W I T N E S S E I H:

WHEREAS, pursuant to Government Code Section 31000, County may contract
with independent contractors for the furnishing of such services to or for County or any
Department thereof;

WHEREAS, the parties entered into an agreement for **Optometry** services for
the term of October 1, 2022 through September 30, 2025, in an amount not to exceed \$
427,205.00 (the "Agreement"); and

WHEREAS, effective April 1, 2024 the parties amended the agreement to clarify
compensation and medical director terms and added \$ 25,000.00 to the "not to
exceed", increasing that amount to \$ 452,205.00; and

WHEREAS, the parties desire to increase the "not to exceed" amount by \$
40,000.00 to an amount not to exceed \$ 492,205.00 for increased clinic coverage
effective August 1, 2025 with no change to the compensation method or formula of the
agreement, and

WHEREAS, the parties wish to extend the term of the agreement by one month
for a term of October 1, 2022 through October 31, 2025;

**NOW, THEREFORE, IT IS HEREBY AGREED BY THE PARTIES HERETO AS
FOLLOWS:**

1. **EXHIBIT B** (entitled "**PAYMENTS**") Section IV. Is amended to read as follows:

Effective August 1, 2025, total payment for services under this Agreement will not
exceed FOUR HUNDRED NINETY TWO THOUSAND TWO HUNDRED FIVE
DOLLARS (\$452,205).

2. Section 3.1 of the Agreement (entitled "**Term**") is amended to read as follows:

Subject to compliance with all terms and conditions, the term of this Agreement is
October 1, 2022 through October 31, 2025. Each consecutive 12-month period

within the term of this Agreement beginning with the first day of this term shall constitute a "Contract Year", and any period of less than a Contract Year at the end of the term shall be treated pro rata for purposes of Contract Year services and compensation.

3. **All other terms and conditions of the Agreement shall remain in full force and effect.**

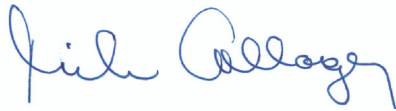
